ORDER OF THE BOARD

On this day, the Texas Board of Nursing, hereinafter referred to as the Board, accepted the voluntary surrender of Registered Nurse License Number 621946, issued to JAMES R. HEBNER, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Respondent is currently licensed to practice professional nursing in the State of Texas.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
3. Respondent received an Associate Degree in Nursing from Tarrant County Junior College, Fort Worth, Texas, on December 1, 1994. Respondent was licensed to practice professional nursing in the State of Texas in August 29, 1995.
4. Respondent's professional nursing employment history is unknown.
5. On March 30, 2012, the Texas Board of Nursing notified Respondent of the following allegations:
  - A. On or about May 23, 1991, Respondent was arrested by the Grand Prairie Police Department, Grand Prairie, Texas, for ASSAULT, disposition unknown.

- B. On or about December 6, 1994, Respondent submitted an Application for Licensure for Graduates of Schools in the United States to the Board of Nurse Examiners for the State of Texas in which he provided false, deceptive, and/or misleading information in that he answered "No" to the question: "Have you ever been convicted of a crime other than minor traffic violation?"

Respondent failed to truthfully disclose that on or about May 23, 1991, Respondent was arrested by the Grand Prairie Police Department, Grand Prairie, Texas, for ASSAULT, disposition unknown.

- C. On or about February 27, 2007, Respondent was arrested by the Grand Prairie Police Department, Grand Prairie, Texas, and subsequently charged under Cause No. M-0730244, for RESIST ARREST SEARCH OR TRANSP, a Class A misdemeanor offense. On or about August 14, 2007, Cause No. M-0730244 was dismissed in the County Criminal Court No. 2 of Dallas County, Texas.
6. On April 12, 2012, the Board received a statement from Respondent voluntarily surrendering the right to practice nursing in Texas. A copy of Respondent's statement, received on April 12, 2012, is attached and incorporated herein, by reference, as part of this Order.

#### CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violation of Article 4525(b)(2)&(9) (eff. 9/1/93), TEX. REV. CIV. STAT. ANN., Section 301.452(b)(10), Texas Occupations Code (eff. 9/1/05), and 22 TEX. ADMIN. CODE §217.13(17) (eff. 9/1/94).
4. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
5. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
6. Any subsequent reinstatement of this license will be controlled by Section 301.452 (b), Texas Occupations Code, and 22 TAC §§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.


ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Registered Nurse License Number 621946, heretofore issued to JAMES R. HEBNER, to practice professional nursing in the State of Texas, is accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice professional nursing, use the title of registered nurse or the abbreviation "RN" or wear any insignia identifying himself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a resigtered nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice professional nursing in the State of Texas.
