OPINION AND ORDER OF THE BOARD

At the regularly scheduled public meeting on January 19-20, 2012, the Texas Board of Nursing (Board) considered the following items: (1) The Proposal for Decision (PFD) regarding the above cited matter; (2) Staff's recommendation that the Board correct a typographical error in Ms. Basquez's name throughout the PFD and adopt all of the Findings of Fact and Conclusions of Law in the PFD regarding the vocational nursing license of Sheila Ann Basquez without changes; and (3) Respondent's recommendation to the Board regarding the PFD and order, if any.

The Board finds that after proper and timely notice was given, the above styled case was heard by an Administrative Law Judge (ALJ) who made and filed a PFD containing the ALJ's findings of facts and conclusions of law. The PFD was properly served on all parties and all parties were given an opportunity to file exceptions and replies as part of the record herein. No exceptions were filed by any party.

The Board has authority to review and modify the PFD in accordance with the Government Code §2001.058(e). The Board has determined that the PFD contains a technical error. Ms. Basquez's name is spelled as "Shelia" instead of "Sheila" throughout

the PFD. The Board finds that the PFD should BE MODIFIED under the authority of §2001.058(e)(3) to correct this technical error throughout the PFD.

Further, the Board, after review and due consideration of the PFD, Staff's recommendations, and the presentation by the Respondent during the open meeting, adopts all of the findings of fact and conclusions of law of the ALJ contained in the PFD as if fully set out and separately stated herein. All proposed findings of fact and conclusions of law filed by any party not specifically adopted herein are hereby denied.

IT IS, THEREFORE, ORDERED THAT Permanent Certificate Number 173551, previously issued to SHEILA ANN BASQUEZ, to practice nursing in the State of Texas be, and the same is hereby, REVOKED.

IT IS FURTHER ORDERED that this Order SHALL be applicable to Respondent's multi-state privileges, if any, to practice nursing in the State of Texas.

PROPOSAL FOR DECISION

This matter was scheduled for hearing at 9:00 a.m. on November 16, 2011, at the request of the Texas Board of Nursing (Board/Staff). Despite being sent proper notice, Shelia Ann Basquez (Respondent) did not appear and was not represented at the hearing. For the reasons set out in the Findings of Fact and Conclusions of Law, the Administrative Law Judge finds that the relief requested by the Board should be granted on a default basis.

FINDINGS OF FACT

- 1. Notice of the hearing was mailed to Respondent at the Respondent's address of record at least ten days prior to the scheduled hearing.
- 2. The notice of hearing contained a statement of the time, place, and nature of the hearing; a statement of the legal authority and jurisdiction under which the hearing was to be held; a reference to the particular sections of the statutes and rules involved; and a short plain statement of the matters asserted.
- 3. The notice of hearing contained a statement in at least 12-point, boldface type that the factual allegations listed in the notice could be deemed admitted, and the relief sought in the notice of hearing might be granted by default against a party that failed to appear at the hearing.
- 4. The hearing was held and the record closed on November 16, 2011.
- 5. Respondent did not appear at the scheduled hearing and was not represented at the hearing.
- 6. Staff moved for a default, which was granted.
- 7. The factual allegations set out in the notice of hearing are deemed admitted and are incorporated by reference into this Finding of Fact.

CONCLUSIONS OF LAW

- 1. The State Office of Administrative Hearings has jurisdiction over matters related to the hearing in this proceeding, including the authority to issue a proposal for decision with findings of fact and conclusions of law. Tex. Gov't Code ch. 2003.
- 2. The Texas Board of Nursing (the Board) has jurisdiction over this matter.
- 3. Proper and timely notice was provided to Respondent in accordance with Tex. Gov'T Code ch. 2001 and 1 Tex. Admin. Code ch. 155.
- 4. The allegations in the notice of hearing were properly deemed admitted. 1 Tex. ADMIN. CODE § 155.501.
- 5. Staff has established the basis for the revocation of Respondent's license as alleged in the notice of hearing, which is incorporated into this Conclusion of Law.
- 6. The Board is entitled to the relief requested in its notice of hearing. 22 Tex. ADMIN. CODE § 213.33.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

CHARGE I.

On or about January 5, 2008, through February 21, 2008, while employed with Elsie Gayer Health Care Center, San Angelo, Texas, part of Baptist Memorials Center, San Angelo, Texas, Respondent signed out Hydrocodone on the Record of Controlled Substance sheet for patients LC, LW & MS, but failed to correctly and accurately document the administration of medication including signs, symptoms and responses to the medication administered in the patients' Medication Administration Records (MARs) and/or Nurses Notes as follows:

Respondent's conduct was likely to injure the patients in that subsequent care givers would rely on her documentation to further medicate the patient which could result in an overdose.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(13), Texas Occupations Code, and is a violation of 22 TEX. ADMIN. CODE §217.11(1)(A),(B)&(D) and 22 TEX. ADMIN. CODE §217.12(1)(A),(1)(B),(1)(C)&(4).

CHARGE II.

On or about January 5, 2008, through February 21, 2008, while employed with Elsie Gayer Health Care Center, San Angelo, Texas, part of Baptist Memorials Center, San Angelo, Texas, Respondent misappropriated Hydrocodone belonging to the facility and patient thereof, or failed to take precautions to prevent such misappropriation. Respondent's conduct was likely to defraud the facility and patients of the cost of the medications.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10), Texas Occupations Code, and is a violation of 22 TEX. ADMIN. CODE §217.12(1)(A),(1)(B),(6)(G)&(8).

CHARGE III.

On or about October 15, 2008, Respondent plead "Guilty" to "Fraud Possession Controlled Substance/Prescription" (a 3rd degree Felony committed on February 2, 2008) in the 51st District Court of Tom Green County, Texas, Cause Number A-08-0650-SA. As a result of the plea, Respondent received deferred adjudication and was placed on community supervision for a period of six years.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(3)&(10), Texas Occupations Code, and is a violation of 22 TEX. ADMIN. CODE §217.12 (13).
