## **ORDER OF TEMPORARY SUSPENSION**

A public meeting of the Texas Board of Nursing was held on November 14, 2011 at 333 Guadalupe, Room 2-225, Austin, Texas, in which the Temporary Suspension of Permanent Vocational Nurse License Number 200528, issued to FEATHER DARISE MURRAY was considered pursuant to Section 301.4551, TEXAS OCCUPATIONS CODE. Staff of the Texas Board of Nursing appeared and presented evidence and information concerning the conduct of FEATHER DARISE MURRAY and whether her continued practice as a nurse would constitute a continuing and imminent threat to the public welfare.

After review and due consideration of the evidence and information presented, the Board finds that the following charges are substantiated:

On or about July 26, 2011, Respondent became non-compliant with the Agreed Order issued to her by the Texas Board of nursing on July 28, 2010. Non-compliance is the result of her failure to comply with all requirements of the Texas Peer Assistance Program for Nurses (TPAPN) contract in that Respondent failed to complete the enrollment process in a timely manner. Stipulation Number Three (1) of the Order dated July 28, 2010, reads, in pertinent part:

(1) RESPONDENT SHALL, within forty-five (45) days following the date of entry of this final Order, apply to TPAPN and SHALL, within ninety (90) days following the date of entry of this final order, sign and execute the TPAPN participation agreement,

which SHALL include payment of a non-refundable participation fee in the amount

of three hundred and fifty dollars (\$350.00) payable to TPAPN.

The Texas Board of Nursing further finds that, given the nature of the allegations concerning

her fitness to practice, the continued practice of nursing by FEATHER DARISE MURRAY

constitutes a continuing and imminent threat to public welfare and that the temporary suspension of

Vocational Nurse License No. 200528 is justified pursuant to Section 301.4551, TEXAS

OCCUPATIONS CODE.

NOW, THEREFORE, IT IS ORDERED that Permanent Certificate Number 200528, issued

to FEATHER DARISE MURRAY, to practice nursing in the State of Texas be, and the same is

hereby, SUSPENDED IMMEDIATELY in accordance with Section 301.4551, TEXAS OCCUPATIONS

CODE.

IT IS FURTHER ORDERED that a probable cause hearing be conducted in accordance with

Section 301.455(c) not later than seventeen (17) days following the date of the entry of this order,

and a final hearing on the matter be conducted in accordance with 301.455(d) not later than the 61st

day following the date of the entry of this order.
