ORDER

On this day the Texas Board of Nursing, hereinafter referred to as the B considered the matter of DELISA A. KELM, Vocational Nurse License Number 173815, hereir referred to as Respondent.

Information received by the Board produced evidence that Respondent may have violated Section 301.452(b)(10)&(13), Texas Occupations Code. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order offered on April 14, 2009, by Katherine A. Thomas, MN, RN, Executive Director, subject to ratification by the Board.

#### **FINDINGS OF FACT**

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
- 2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
- 3. Respondent is currently licensed to practice vocational nursing in the State of Texas.
- 4. Respondent received a Certificate in Vocational Nursing from South Plains College-Plainview Extension, Plainview, Texas, on August 12, 1999. Respondent was licensed to practice vocational nursing in the State of Texas on October 13, 1999.
- 5. Respondent's vocational nursing employment history includes:

- 6. At the time of the initial incident, Respondent was employed as a Licensed Vocational Nurse with Interim Healthcare of West, Texas L.L.C., Lubbock, Texas, and had been in this position for one (1) year and two (2) months.
- 7. On or about February 2006 through August 2007, while employed with Interim Healthcare of West Texas, LLC, Lubbock, Texas, Respondent submitted and/or produced fraudulent bids for Community Based Alternative (CBA) home modifications. Respondent's conduct deceived her employer and may have placed patients at risk of injury from inappropriate and/or non-efficacious Community Based Alternative (CBA) home modifications.
- 8. In Response to Finding of Fact Number Seven (7), Respondent states; "when I began working, the CBA program of Plainview only used one contractor. I began searching for contractors to do the minor modifications for the CBA clients. I found three contractors in Plainview. I used T.T. on one occasion. He completed the job but did not like the fact that it was up to 60 days before he was paid for the job. He stated that his company was mainly for major home/building repairs, and requested that I not use him again. I used L.H. on one occasion. He did a good job but it was difficult for him to complete the job in the time frame that was required. I did not use him for any other jobs. I was left with one contractor in the area. I explained this to my supervisor. Knowing that I had to have three contractor bids, she explained to me the procedure they used in the Lubbock office when she did not have enough contractors for a job. She said that she would choose the contractor that she wanted and allow him to do the written specifications. Once the specifications were turned in she would make up a bid sheet. On the bid sheet she would write down three contractors and 'make up' the bids for the other two contractors. She would make the bids higher than the contractor of choice bids. She explained that if I did call and attempt to receive three true

- bids and I did not have a response within a time frame, then I could write a 2067 stating that only one contractor turned in a bid. She stated that it was just easier to make up the bids than to try and get three true bids. I did this on or about March 2006 through August 2007."
- 9. On or about February 2006 through August 2007, while employed with Interim Healthcare of West Texas, LLC, Lubbock, Texas, Respondent selected contractors and/or inspectors for the Community Based Alternative (CBA) home modifications that did not meet the standard qualifications, and as a result the health and safety of the clients were jeopardized.
- In Response to Finding of Fact Number Nine (9), Respondent states; "The inspectors were required to read and sign a letter acknowledging that they read and understood the TAS Standards. They were also aware that all minor home modifications had to meet TAS Standards, and must also meet the written specifications of the contractor. I kept the contractors qualifications and letters of acknowledgment of TAS standards. I used L.H and V.F. for a majority of the inspections. However, I did use J.K. on some inspection in February 2007. I feel that I did make a wrong decision to make up bids for the home modifications. I feel that I was performing the job that I was taught. I do feel that this allegation is incorrect. I followed the CBA manual in choosing the contractors and inspectors, all of which met the CBA requirements. I do not feel that the CBA clients were in harms way."

### **CONCLUSIONS OF LAW**

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violations of Section 301.452(b)(10)&(13), Texas Occupations Code, 22 TEX. ADMIN. CODE §217.11(1)(B), and 22 TEX. ADMIN. CODE §217.12(1)(B),(4),(6)(A)&(H).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 173815, heretofore issued to DELISA A. KELM, including revocation of Respondent's license to practice vocational nursing in the State of Texas.

### **ORDER**

IT IS THEREFORE AGREED and ORDERED, subject to ratification by the Texas

Board of Nursing, that RESPONDENT SHALL receive the sanction of a REPRIMAND WITH STIPULATIONS, and RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Texas Occupations Code, §§301.001 et seq., the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 et seq. and this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privilege, if any, to practice nursing in compact states.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the Texas Board of Nursing and the Board of Nursing in the party state where Respondent wishes to work.

# IT IS FURTHER AGREED that:

- (1) RESPONDENT SHALL deliver the wallet-sized license issued to DELISA A. KELM, to the office of the Texas Board of Nursing within ten (10) days from the date of ratification of this Order.
- (2) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in Texas nursing jurisprudence and ethics. RESPONDENT SHALL obtain Board approval of the course prior to enrollment only if the course is <u>not</u> being offered by a pre-approved provider. Home study courses and video programs will not be approved. In order for the course to be approved, the target audience shall include nurses. It shall be a minimum of six (6) hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding: Sexual Misconduct; Fraud, Theft and Deception;

Nurses with Substance Abuse, Misuse, Substance Dependency, or other Substance Use Disorder; and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. RESPONDENT SHALL CAUSE the sponsoring institution to submit a Verification of Course Completion form, provided by the Board, to the Office of the Board to verify RESPONDENT's successful completion of the course. This course shall be taken in addition to any other courses stipulated in this Order, if any, and in addition to any continuing education requirements the Board has for relicensure. (3) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete the course "Sharpening Critical Thinking Skills," a 3.6 contact hour online program provided by the National Council of State Boards of Nursing (NCSBN) Learning Extension. In order to receive credit for completion of this program, RESPONDENT SHALL SUBMIT the continuing education certificate of completion for this program to the Board's office, to the attention of Monitoring. This course is to be taken in addition to any continuing education requirements the Board may have for relicensure. *Information regarding*

(4) RESPONDENT SHALL pay a monetary fine in the amount of two hundred fifty dollars (\$250). RESPONDENT SHALL pay this fine within forty-five (45) days of entry of this Order. Payment is to be made directly to the Texas Board of Nursing in the form of cashier's check or U.S. money order. Partial payments will not be accepted.

IT IS FURTHER AGREED, SHOULD RESPONDENT PRACTICE AS A NURSE IN THE

STATE OF TEXAS, RESPONDENT WILL PROVIDE DIRECT PATIENT CARE AND PRACTICE IN A HOSPITAL, NURSING HOME, OR OTHER CLINICAL SETTING AND RESPONDENT MUST WORK IN SUCH SETTING A MINIMUM OF SIXTY-FOUR (64) HOURS PER MONTH UNDER THE FOLLOWING STIPULATIONS FOR TWO (2) YEARS OF EMPLOYMENT. THE LENGTH OF THE STIPULATION PERIOD WILL BE EXTENDED UNTIL SUCH TWENTY-FOUR (24) MONTHS HAVE ELAPSED. PERIODS OF UNEMPLOYMENT OR OF EMPLOYMENT THAT DO NOT REQUIRE THE USE OF A VOCATIONAL NURSE (LVN) LICENSE WILL NOT APPLY TO THIS STIPULATION PERIOD:

- (5) RESPONDENT SHALL notify each present employer in nursing of this Order of the Board and the stipulations on RESPONDENT's license. RESPONDENT SHALL present a complete copy of this Order and all Proposals for Decision issued by the Administrative Law Judge, if any, to each present employer within five (5) days of receipt of this Order. RESPONDENT SHALL notify all future employers in nursing of this Order of the Board and the stipulations on RESPONDENT's license. RESPONDENT SHALL present a complete copy of this Order and all Proposals for Decision issued by the Administrative Law Judge, if any, to each future employer prior to accepting an offer of employment.
- (6) RESPONDENT SHALL CAUSE each present employer in nursing to submit the Notification of Employment form, which is provided to the Respondent by the Board, to the Board's office within ten (10) days of receipt of this Order. RESPONDENT SHALL CAUSE each future employer to submit the Notification of Employment form, which is provided to the Respondent by the Board, to the Board's office within five (5) days of employment as a nurse.

(7) RESPONDENT SHALL be supervised by a Registered Nurse or a Licensed Vocational Nurse who is on the premises. The supervising nurse is not required to be on the same unit or ward as RESPONDENT, but should be on the facility grounds and readily available to provide assistance and intervention if necessary. The supervising nurse shall have a minimum of two (2) years experience in the same or similar practice setting to which the Respondent is currently working. RESPONDENT SHALL work only regularly assigned, identified and predetermined unit(s). RESPONDENT SHALL NOT be employed by a nurse registry, temporary nurse employment agency, hospice, or home health agency. RESPONDENT SHALL NOT be self-employed or contract for services. Multiple employers are prohibited.

(8) RESPONDENT SHALL CAUSE each employer to submit, on forms provided to the Respondent by the Board, periodic reports as to RESPONDENT's capability to practice nursing. These reports shall be completed by the Registered Nurse or Licensed Vocational Nurse who supervises the RESPONDENT. These reports shall be submitted by the supervising nurse to the office of the Board at the end of each three (3) month period for two (2) years of employment as a nurse.

IT IS FURTHER AGREED, that upon full compliance with the terms of this Order, all encumbrances will be removed from RESPONDENT's license and RESPONDENT shall be eligible for multistate licensure privileges, if any, to practice nursing in the State of Texas.
