ORDER

On this day, the Texas Board of Nursing, hereinafter referred to as the Boar accepted the voluntary surrender of Registered Nurse License Number 623027, issued to DWIGHT RAYMOND CLEMANS, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was provided to Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
- 3. Respondent is currently licensed to practice professional nursing in the State of Texas.
- 4. Respondent received an Associate Degree in Nursing from Arkansas on May 1, 1973. Respondent was licensed to practice professional nursing in the State of Texas on October 13, 1995. Respondent completed a Gerontological Nurse Practitioner program from the United States Air Force and completed a Family Nurse Practitioner program from the University of Nebraska on November 3, 1976. Respondent received authorization from the Board to practice as a Gerontological Nurse Practitioner on October 18, 1995 and received authorization from the Board to practice as a Family Nurse Practitioner on January 12, 1996.
- 5. Respondent's nursing employment history is unknown.

- 6. On or about March 4, 2011, Respondent was arrested by the Harrison County Sheriff's Office, Marshall, Texas, for the offense of SEXUAL ASSAULT OF A CHILD, a 2nd Degree Felony. On April 1, 2011, Respondent was indicted for the offense of SEXUAL ASSAULT by the Grand Jury of the 71st District Court of Harrison County, Texas.
- 7. Respondent, by his signature to this Order, expresses his desire to voluntarily surrender his license(s) to practice nursing in the State of Texas.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violations of Section 301.452(b)(10), Texas Occupations Code, and 22 Tex. ADMIN. CODE §217.12(13).
- 4. The evidence received is sufficient cause pursuant to Section 301.453(a), Texas Occupations Code, to take disciplinary action against Registered License Number 623027, heretofore issued to DWIGHT RAYMOND CLEMANS, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
- 5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
- 6. Under Section 301.453(d), Texas Occupations Code, as amended, the Board may impose conditions for reinstatement of licensure.
- 7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 Tex. ADMIN. CODE §213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

<u>ORDER</u>

NOW, THEREFORE, IT IS AGREED and ORDERED that the VOLUNTARY SURRENDER of Registered License Number 623027, heretofore issued to DWIGHT RAYMOND CLEMANS, to practice nursing in the State of Texas, is accepted by the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

- 1. RESPONDENT SHALL NOT practice professional nursing, use the title "registered nurse" or the abbreviation "RN" or wear any insignia identifying himself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
- 2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
- 3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.


