On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of DEDE DESANTIS MCCLAMROCH, Registered Nurse License Number 454495, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may be subject to discipline pursuant to Section 301.452(b)(8), Texas Occupations Code. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order offered on August 7, 2012, by Katherine A. Thomas, MN, RN, FAAN, Executive Director.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice professional nursing in the State of Texas.
4. Respondent received an Associate Degree in Nursing from Northwestern State University, Natchitoches, Louisiana on May 1, 1977. Respondent received a Baccalaureate Degree in Nursing from University of Texas Medical Branch, Galveston, Texas on May 1, 1993. Respondent was licensed to practice professional nursing in the State of Texas on August 21, 1880.
5. Respondent's complete nursing employment history is unknown.

6. On or about June 7, 2012, Respondent entered into an Consent Order with the Louisiana State Board of Nursing wherein Respondent's license to practice professional nursing in the State of Louisiana was issued a Letter of Reprimand with terms and conditions for performing procedures outside the scope of practice. A copy of the Consent Order issued by the Louisiana State Board of Nursing, dated June 7, 2012, is attached and incorporated by reference as a part of this Order.
7. In response to Finding of Fact Number Six (6), Respondent states she did perform procedures she was authorized to do, but they required the supervision of a physician. There was no physician present in the building when she performed these procedures.

### CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555 , the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient cause pursuant to Section 301.452(b)(8), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 454495, heretofore issued to DEDE DESANTIS MCCLAMROCH, including revocation of Respondent's license(s) to practice nursing in the State of Texas.

### ORDER

IT IS THEREFORE AGREED and ORDERED that RESPONDENT SHALL receive the sanction of a REMEDIAL EDUCATION, and RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Texas Occupations Code §§301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 *et seq.* and this Order.

IT IS FURTHER AGREED and ORDERED that, while under the terms of this Order, this Order SHALL apply to any and all future licenses issued to Respondent to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license(s) is/are encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a nurse licensure compact privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED that:

(1) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in Texas nursing jurisprudence and ethics. RESPONDENT SHALL obtain Board approval of the course prior to enrollment only if the course is not being offered by a pre-approved provider. Home study courses and video programs will not be approved. In order for the course to be approved, the target audience shall include nurses. It shall be a minimum of six (6) hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding: Sexual Misconduct; Fraud, Theft and Deception; Nurses with Substance Abuse, Misuse, Substance Dependency, or other Substance Use Disorder; and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. RESPONDENT SHALL CAUSE the sponsoring institution to submit a Verification of Course Completion form, provided by the Board, to the Office of the Board to verify RESPONDENT'S successful completion of the course. This course shall be taken in addition to any other courses stipulated in this Order, if any, and in addition to any continuing education requirements the Board has for relicensure. *Board-approved courses may be found at the following Board website address:*




RESPONDENT'S CERTIFICATION



CONSENT ORDER

TERMS AGREED TO BY LICENSEE

I, **DEDE DESANTIS MCCLAMROCH**, voluntarily agree to sign and have witnessed terms of agreement for the purpose of avoiding formal administrative proceedings with the Louisiana State Board of Nursing.

I, **DEDE DESANTIS MCCLAMROCH**, do say that I freely, knowingly and voluntarily enter into this agreement; that I understand that I have a right to a hearing in this matter and I freely waive such right; I understand that I have a right to legal counsel prior to entering into this agreement.

I acknowledge that the Louisiana State Board of Nursing makes the following FINDINGS OF FACT:

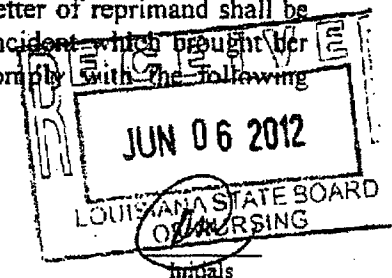
1. On or about September 1, 1977, Respondent was licensed by examination to practice as a Registered Nurse in Louisiana.
2. During 2010 through 2012, Respondent performed procedures outside her scope of practice, specifically, Derma Fillers and performed other procedures such as Botox Injections and Microdermabrasion, without a physician present in the building.

To facilitate submission of this Consent Order, I do not offer any defense to the FINDINGS OF FACT. I agree that the Board has jurisdiction of this matter pursuant to L.R.S. 37:911 et seq. I do not admit to the findings of fact. While I do not admit to violating any federal or state law, I understand that the Board is able to prove, because I do not offer a defense, a finding of violation of the provisions of L.R.S. 37:921. I agree that the Board may treat the allegations of fact and law as true, which finding shall have the same force and effect as if evidence and argument were presented in support of the allegations and, based thereon, the Board found the allegations to be true. I specifically waive my right to contest these findings in any subsequent proceedings before the Board. I understand that this Consent Order shall constitute a public record and is disciplinary action by the Board. I understand that this will be reported to Healthcare Integrity and Protection Data Bank (HIPDB) as: 29, Practiced Beyond the Scope of Practice.

Specify HIPDB Narrative: RN was issued a letter of reprimand after RN performed procedures outside the scope of practice, specifically, Derma Fillers, Botox injections and Microdermabrasion.

I further acknowledge and attest that I have fully cooperated with the Louisiana State Board of Nursing in resolving these charges, and intend to comply with all stipulations of this order.

In order to avoid further administrative proceedings, I, **DEDE DESANTIS MCCLAMROCH**, hereby consent to accept and abide by the following ORDER of the Board: That a letter of reprimand shall be issued and become a part of this Registrant's permanent file regarding the incident which brought her before the Board, Practiced Beyond the Scope of Practice, she shall comply with the following stipulations:

CONSENT ORDER

TERMS AGREED TO BY LICENSEE, CONT'D

1. Within three (3) months, submit written evidence of completion of 10 hours of LSBN staff approved continuing education hours in Ethics/Professionalism in Nursing and Professional Accountability.
2. Within three (3) months, submit two hundred dollars (\$200.00) as cost to the Board.
3. Within twelve (12) months, submit two thousand dollars (\$2,000.00) to the Board as fine.
4. Not have any misconduct, criminal violations, or violations of any health care regulations reported to the Board related to this or any other incidents.
5. Failure to comply with the above stipulations shall result in the immediate suspension of this registrant's license.
6. This suspension can be imposed by action of the Executive Director subject to discretionary review by the Board.

I, DEDE DESANTIS MCCLAMROCH, understand that this agreement is effective immediately upon signature of the Executive Director and will become an ORDER of the Board. It is also understood that this agreement does not preclude the Board of Nursing from requiring a formal hearing of my case. I further understand that should the Consent Order not be accepted by the Board, I agree that presentation to and consideration of the Consent Order, the documentary evidence and information by the Board shall not unfairly or illegally prejudice the Board or any of its members from participation in hearings or other proceedings pertaining to these or other matters regarding this registrant.
