A public meeting of the Texas Board of Nursing was held on _October 3, 2012_ at 333 Guadalupe, Room 2-225, Austin, Texas, in which the Temporary Suspension of Permanent Registered Nurse License Number 795094, issued to ALAN JAY NORRIS was considered pursuant to Section 301.4551, Texas Occupations Code. Staff of the Texas Board of Nursing appeared and presented evidence and information concerning the conduct of ALAN JAY NORRIS and whether his continued practice as a nurse would constitute a continuing and imminent threat to the public welfare.

After review and due consideration of the evidence and information presented, the Board finds that the following charges are substantiated:

On or about August 3, 2012, Respondent became non-compliant with the Agreed Eligibility Order issued to him by the Texas Board of Nursing on December 16, 2010. Non-compliance is the result of Respondent's failure to comply with all requirements of the Texas Peer Assistance Program for Nurses (TPAPN) contract in that he submitted a specimen for a drug screen which resulted positive for Ethyl Glucuronide (EtG) and Ethyl Sulfate (Ets). Stipulation Number Three (3) of the Agreed Eligibility Order dated December 16, 2010, states:

"(3) PETITIONER SHALL comply with all requirements of the TPAPN contract during its term."

On or about August 15, 2012, Respondent was dismissed from TPAPN and referred to the

Texas Board of Nursing. A copy of the Findings of Fact, Conclusions of Law, and Agreed

Eligibility Order dated December 16, 2010, is attached and incorporated, by reference, as part

of this pleading.

The Texas Board of Nursing further finds that, given the nature of the charges concerning

his fitness to practice, the continued practice of nursing by ALAN JAY NORRIS constitutes a

continuing and imminent threat to public welfare and that the temporary suspension of Permanent

Registered Nurse License Number 795094, is justified pursuant to Section 301.4551, TEXAS

OCCUPATIONS CODE.

NOW, THEREFORE, IT IS ORDERED that Permanent Registered Nurse License Number

795094, issued to ALAN JAY NORRIS, to practice nursing in the State of Texas be, and the same

is/are, hereby SUSPENDED IMMEDIATELY in accordance with Section 301.4551, TEXAS

OCCUPATIONS CODE.

IT IS FURTHER ORDERED that a probable cause hearing be conducted in accordance with

Section 301.455(c) not later than seventeen (17) days following the date of the entry of this order,

and a final hearing on the matter be conducted in accordance with 301.455(d) not later than the 61st

day following the date of the entry of this order.
