§ ORDER

On this day the Board of Nurse Examiners for the State of Texas, hereinafter referred to as the Board, considered the matter of LAUREE SNIDER, License Number 640977, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may have violated Section 301.452(b)(10), (12) Texas Occupations Code. Respondent waived representation by counsel, informal conference, notice and hearing, and agreed to the entry of this Order offered on May 21, 2004, by Katherine A. Thomas, MN, RN, Executive Director.

# FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
- 2. Respondent waived representation by counsel, informal conference, notice and hearing, and agreed to the entry of this Order.
- 3. Respondent is currently licensed to practice professional nursing in the State of Texas.
- 4. Respondent received an Associate Degree in Nursing from Alvin Community College, Alvin, Texas, on May 1, 1997. Respondent was licensed to practice professional nursing in the State of Texas on June 17, 1997.
- 5. Respondent's complete professional employment history is unknown.

I do hereby certify this to be a complete, accurate, and true copy of the document wh is on file or is of record in the offices of the Texas Board of Nursing.

Executive Director of the Board

- Respondent lacked fitness to practice professional nursing in that she received treatment at St. John's Hospital in Texas City, Texas, following a drug overdose, then on a separate occasion received treatment at St. John's Hospital in Clear Lake, Texas for a second overdose where she ingested forty-eight (48) Tylenol PM.
- 7. On or about August 29, 2003, Respondent plead nolo contendere to the offense "Driving While Intoxicated/Open Container," a Class B Misdemeanor, in the County Court at Law No. 3 Galveston, Texas, Cause Number 222813. Respondent was sentenced to twelve (12) months probation, a \$400 fine, was ordered to attend DWI school, submit to an alcohol & drug evaluation, and to abstain from consumption of alcoholic beverages during the probationary period.
- 8. On or about September 5, 2001, Respondent plead nolo contendere to the offense "Obstruction of a Highway Passage," a Class B Misdemeanor, in the County Court at Law No. 2 Galveston, Texas, Cause Number 202012. Respondent was sentenced to nine (9) months probation, a \$400 fine, and was ordered to participate in drug screening to detect controlled substances.
- 9. The Respondent's conduct described in the preceding Findings of Fact was reportable under the provisions of Sections 301.401-301.419, Texas Occupations Code.
- 10. The Board finds that there exists serious risks to public health and safety as a result of impaired nursing care due to intemperate use of controlled substances, chemical dependency, or mental illness.
- 11. Respondent's conduct described in Finding of Fact Numbers six (6), seven (7) & eight (8) resulted from Respondent's impairment due to chemical dependency or mental illness.
- 12. Respondent's compliance with the terms of a Board approved peer assistance program should be sufficient to protect patients and the public.

### CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.455, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violations of Section 301.452(b)(10) &(12), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(1).

- 4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against License Number 640977, heretofore issued to LAUREE SNIDER, including revocation of Respondent's professional license to practice nursing in the State of Texas.
- 5. The Board may, in its discretion, order a nurse to participate in a peer assistance program approved by the Board if the nurse would otherwise have been eligible for referral to peer assistance pursuant to Section 301.410, Texas Occupations Code.

# **ORDER**

IT IS THEREFORE AGREED and ORDERED that RESPONDENT, in lieu of the sanction of Revocation under Section 301.453, Texas Occupations Code, SHALL comply with the following conditions for such a time as is required for RESPONDENT to successfully complete the Texas Peer Assistance Program for Nurses (TPAPN):

- (1) RESPONDENT SHALL, within forty-five (45) days following the date of entry of this final Order, apply to and be accepted into the TPAPN, which SHALL include payment of a non-refundable participation fee in the amount of five hundred dollars (\$500) payable to TPAPN.
- (2) Upon acceptance into the TPAPN, RESPONDENT SHALL waive confidentiality and provide a copy of the executed TPAPN contract to the Board of Nurse Examiners.
- (3) RESPONDENT SHALL comply with all requirements of the TPAPN contract during its term.
- (4) RESPONDENT SHALL CAUSE the TPAPN to notify the Board of Nurse Examiners of any violation of the TPAPN contract.

IT IS FURTHER AGREED and ORDERED, RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Revised Civil Statutes of Texas as amended, Texas Occupations Code, Section §§301.001 et seq., the Rules and Regulations Relating to Professional

Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.01 et seq. and this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privileges, if any, to practice professional nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED, SHOULD RESPONDENT fail to comply with this Order or the terms of the participation agreement with the TPAPN, such noncompliance will result in further disciplinary action including revocation of Respondent's license and multistate licensure privileges, if any, to practice professional nursing in the State of Texas.

### **FORMAL CHARGES**

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, LAUREE SNIDER, is a Registered Nurse holding license number 640977, which is in current status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

#### CHARGE I.

On or about July 13, 2005, Respondent failed to comply with the Agreed Order issued by the Board of Nurse Examiners for the State of Texas on July 27, 2004. Noncompliance is the result of Respondent's failure to comply with all requirements of the Texas Peer Assistance Program for Nurses (TPAPN) contract during its term. Since April 2005, Respondent failed to call in and submit to random drug testing; failed to submit evidence of meeting attendance; and failed to submit evidence of quarterly employer meetings.

A copy of the July 27, 2004, Agreed Order, Findings of Fact, and Conclusions of Law is attached and incorporated, by reference, as part of this pleading.

The above action constitutes a violation of Section 301.452(b)(1) and (10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(11)(B), as amended September 28, 2004.
