## AGREED BOARD ORDER

On this day came to be considered by the Board of Vocational Nurse Examiners for the State of Texas, hereinafter referred to as the Board, the matter of vocational nurse license number 126971, held by JANICE LYNN TITTLE hereinafter called Respondent.

A sworn Complaint has been filed and served on the Respondent, which alleges violations of the Texas Occupations Code, Chapter 302, and grounds to take disciplinary action against Respondent.

An informal conference was held on October 2, 2003, at the office of the Board of Vocational Nurse Examiners. The conference was conducted by Terrie L. Hairston, R.N., C.H.E., Hearing Officer, assisted by Ms. Rachel Gomez, LVN, member of the Board of Vocational Nurse Examiners. Respondent was present and was represented by counsel.

The conference was attended by Shelly Johnson, LVN, Investigator for the Board, and Mr. Eugene Clayborn, Assistant Attorney General. By their notarized signature on this Order, Respondent does hereby waive the right to Notice of Formal Hearing and a Formal Hearing of the Complaint before the Board, and to judicial review of this disciplinary action after this Order is ratified by the Board.

After reviewing the Complaint and information provided at the informal conference,

Respondent agrees to the entry of an Order dispensing with the need for further

proceedings on the Complaint. By Respondent's signature on this Order, Respondent

neither admits nor denies the truth of the allegations stated in the Complaint. By

Respondent's signature on this Order, Respondent acknowledges that they have read

and understood this Order and have approved it for consideration by the Board. Notice

of this disciplinary action will appear in the Board's newsletter sent to Texas employers.

ORDER OF THE BOARD

NOW THEREFORE, IT IS ORDERED, that license number 126971, heretofore issued to

JANICE LYNN TITTLE to practice vocational nursing in the State of Texas be, and the

same is hereby REPRIMANDED.

IT IS FURTHER ORDERED, that Respondent shall successfully complete nursing program

course(s) encompassing the following areas of study: Legal Aspects of Nursing (to

include Charting), and submit documentation of successful course completion to the Board

office within the first six (6) months of the Board's ratification of this Order. Respondent shall

be responsible for locating said course(s) and obtaining prior written approval of Board staff

prior to committing to said course(s). Said course(s) shall be through correspondence

(through a recognized provider), in-house at a community college, university or nursing

program, and/or tutored by a state approved, licensed nursing program faculty member.

The expense of said course(s) shall be borne by Respondent. Failure to successfully

complete said course(s) within the time frame stipulated, shall be considered a violation of

this Order.

This Agreed Order shall not be effective or take effect and become enforceable in accordance with its terms until ratified by a majority of the Board present and voting, at its next regularly called session.


