ORDER OF THE BOARD

During open meeting held in Austin, Texas, on December 18, 2012, the Texas Board of Nursing Eligibility and Disciplinary Committee (hereinafter "Committee") heard the above-styled case, based on the failure of the Respondent to appear as required by 22 TEX. ADMIN. CODE Ch. 213.

The Committee finds that notice of the facts or conduct alleged to warrant disciplinary action has been provided to Respondent in accordance with Texas Government Code § 2001.054(c) and Respondent has been given an opportunity to show compliance with all the requirements of the Nursing Practice Act, Chapter 301 of the Texas Occupations Code, for retention of Respondent's license(s) to practice nursing in the State of Texas.

The Committee finds that the Formal Charges were properly initiated and filed in accordance with section 301.458, Texas Occupations Code.

The Committee finds that after proper and timely Notice regarding the violations alleged in the Formal Charges was given to Respondent in this matter, Respondent has failed to appear in accordance with 22 TEX. ADMIN. CODE Ch. 213.

The Committee finds that the Board is authorized to enter a default order pursuant to Texas Government Code § 2001.056.


All proposed findings of fact and conclusions of law filed by any party not specifically adopted herein are hereby denied.

FORMAL CHARGES

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, EE-YONG MOLLY CHIN, has a Privilege to Practice from New Mexico Registered Nurse License Number R62744 and a Registered Nurse holding License Number 437771 which is in delinquent status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

CHARGE I.

On or about January 5, 2012, January 11, 2012, January 27, 2012, and February 16, 2012, while utilizing Respondent's Privilege to Practice from New Mexico Registered Nurse License Number R62744, and employed as a Registered Nurse with Home Care Providers of Texas, Dallas, Texas, Respondent falsely documented providing home health care visits to include vital signs, assessments and teaching to Patient MR#4286. At the time Respondent documented providing home health care to Patient MR#4286, said Patient MR#4286, had been treated at Lake Point Hospital until January 4, 2012, and was subsequently transferred to Beacon Hill Nursing and Rehabilitation on January 4, 2012, where she remained through February 16, 2012. Respondent's conduct defrauded the facility and patient of the cost of respondent's salary and the Medicare/Medicaid cost for visits that she did not actually make.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10), Texas Occupations Code and 22 TEX. ADMIN. CODE §217.12(1)(B), (C), (6)(A), (G), (H) & (11)(B).

NOTICE IS GIVEN that staff will present evidence in support of the recommended disposition of up to, and including, revocation of Respondent's license/s to practice nursing in the State of Texas pursuant to the Nursing Practice Act, Chapter 301, Texas Occupations Code and the Board's rules, 22 Tex. Admin. Code §§ 213.27 - 213.33. Additionally, staff will seek to impose on Respondent the administrative costs of the proceeding pursuant to Section 301.461, Texas Occupations Code. The cost of proceedings shall include, but is not limited to, the cost paid by the Board to the State Office of Administrative Hearings and the Office of the Attorney General or other Board counsel for legal and investigative services, the cost of a court reporter and witnesses, reproduction of records, Board staff time, travel, and expenses. These shall be in an amount of at least one thousand two hundred dollars (\$1200.00).


