## NUNC PRO TUNC ORDER OF THE BOARD

TO: Yanira Monique Marrufo 1810 Broadmoor St. Amarillo, TX 79106

On October 2, 2012, an Agreed Order was ratified by the Executive Director, on behalf of the Texas Board of Nursing (Board) for Yanira Monique Marrufo. However, the Order contained the incorrect effective date. Upon notice and hearing, administrative agencies, like the Courts, have the power to enter nunc pro tunc orders where it can be seen by reference to a record that what was intended to be entered, but was omitted by inadvertence or mistake, can be corrected upon satisfactory proof of its rendition provided that no intervening rights will be prejudiced. *Railroad Comm'n v. McClain*, 356 S.W.2d 330, 334 (Tex. App.--Austin 1962, no writ) (citing *Frankfort Ky. Nat. Gas Co. v. City of Frankfort*, 276 Ky. 199, 123 S.W.2d 270, 272).

The Executive Director, as agent of the Texas Board of Nursing, after review and due consideration of the record and the facts therein, invalidates the Agreed Order of the Board with the incorrect information and submits and enters the corrected Agreed Order of the Board. No other changes to the Order have been made. Ms. Marrufo received due process regarding her license; therefore, her rights have not been prejudiced.

- 4. Respondent received an Associate Degree in Nursing from Amarillo College, Amarillo, Texas, on May 13, 2004. Respondent was licensed to practice professional nursing in the State of Texas on July 1, 2004.
- 5. Respondent's nursing employment history is unknown.

- C. pled nolo contendere, no contest, or guilty?

- F. been sentenced to serve jail or prison time? court-ordered confinement?
- G. been granted pre-trial diversion?
- H. been arrested or have any pending criminal charges?

- J. been subject of a court-martial; Article 15 violation; or received any form of military judgment/punishment/action?"

Respondent disclosed that on or about October 29, 2009, Respondent entered a plea of Guilty and was convicted of DEADLY CONDUCT, a Class A misdemeanor offense committed on April 7, 2009, in the County Court at Law No. 1 of Potter County, Texas, under Cause No. 124,964. As a result of the conviction, Respondent was sentenced to confinement in the Potter County Jail for a period of thirty (30) days. Additionally, Respondent was ordered to pay a fine and court costs.

7. In response to Finding of Fact Number Six (6), Respondent states she was watching the NCAA men's championship game at a local bar with friends and family. After the game was over she had a few drinks to celebrate North Carolina's win. Two hours later she was asked to drive home two cousins. She missed a street and proceeded to a small shopping center where she made a u-turn in the parking lot. At that point she got back on the main street and was pulled over. The officer stated she was making donuts in the parking lot. The officer asked if she had been drinking and she said no, but she had drinks some time before. She was then arrested. She had drank (3 beers) 2 hours prior to giving her cousins a ride home. She now refuses to drink and drive regardless of the time frame and spacing of drinks. She does admit to wrong doing but she made a mistake, this behavior isn't a regular occurrence nor has it happened since. She has learned a valuable lesson.

#### **CONCLUSIONS OF LAW**
