ORDER OF THE BOARD

On this day, the Texas Board of Nursing, hereinafter referred to as the Board, accepted the voluntary surrender of Vocational Nurse License Number 98575, issued to STACY KAY MCQUEEN (SCHOTT), hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Respondent is currently licensed to practice vocational nursing in the State of Texas.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
3. Respondent received a Certificate in Vocational Nursing from South Plains College, Levelland, Texas, on September 7, 1982. Respondent was licensed to practice vocational nursing in the State of Texas on December 13, 1982.

4. Respondent's vocational nursing employment history includes:

5. Formal Charges were filed on July 19, 2013.
6. Formal Charges were mailed to Respondent on July 23, 2013. A copy of the Formal Charges is attached and incorporated, by reference, as part of this Order.
7. On September 20, 2013, the Board received a notarized statement from Respondent voluntarily surrendering the right to practice nursing in Texas. A copy of Respondent's notarized statement, dated September 18, 2013, is attached and incorporated herein by reference as part of this Order.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.11() and 22 TEX. ADMIN. CODE §217.12().
4. The evidence received is sufficient cause pursuant to Section 301.452(b)(), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 98575, heretofore issued to STACY KAY MCQUEEN (SCHOTT), including revocation of Respondent's license(s) to practice nursing in the State of Texas.
5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
6. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.

7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 TAC §§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Vocational Nurse License Number 98575, heretofore issued to STACY KAY MCQUEEN (SCHOTT), to practice nursing in the State of Texas, is accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice vocational nursing, use the title of "vocational nurse" or the abbreviation "LVN" or wear any insignia identifying herself as a vocational nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a vocational nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

FORMAL CHARGES

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, STACY KAY MCQUEEN, is a Vocational Nurse holding License Number 98575, which is in delinquent status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

CHARGE I.

On or about October 27, 2010, to April 6, 2011, while employed as the charge nurse in the Alzheimer's Unit at Childer's Place, Amarillo, Texas, Respondent verbally and/or mentally abused Resident B.P. in that she:

- Told Resident B.P. that her baby doll was retarded
- Told Resident B.P. that Child Protective Services would be coming to take her baby doll away from her
- Hid Resident B.P.'s baby doll under a coffee filter at the nurses station
- Told Resident B.P. that she had a "big butt"
- Told Resident B.P.'s husband that living with the resident should have caused him to have a drinking problem
- Told Resident B.P. that her baby doll was not real

Respondent's conduct created an unsafe environment and unnecessarily exposed the resident to emotional harm.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(13), Texas Occupations Code, and is a violation of 22 TEX. ADMIN. CODE §§217.11(1)(A)&(B) and 217.12(1)(A),(4)&(6)(C).

CHARGE II.

On or about October 27, 2010, to April 6, 2011, while employed as the charge nurse in the Alzheimer's Unit at Childer's Place, Amarillo, Texas, Respondent verbally and/or mentally abused Resident S.Z. in that Respondent repeatedly called and referred to Resident S.Z. as "Achmed." Respondent's conduct created an unsafe environment and unnecessarily exposed the patient to emotional harm.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(13), Texas Occupations Code, and is a violation of 22 TEX. ADMIN. CODE §§217.11(1)(A)&(B) and 217.12(1)(A),(4)&(6)(C).

NOTICE IS GIVEN that staff will present evidence in support of the recommended disposition of up to, and including, revocation of Respondent's license/s to practice nursing in the State of Texas pursuant to the Nursing Practice Act, Chapter 301, Texas Occupations Code and the Board's rules, 22 Tex. Admin. Code §§ 213.27 - 213.33. Additionally, staff will seek to impose on Respondent the administrative costs of the proceeding pursuant to Section 301.461, Texas Occupations Code. The cost of proceedings shall include, but is not limited to, the cost paid by the Board to the State Office of Administrative Hearings and the Office of the Attorney General or other Board counsel for legal and investigative services, the cost of a court reporter and witnesses, reproduction of records, Board staff time, travel, and expenses. These shall be in an amount of at least one thousand two hundred dollars (\$1200.00).

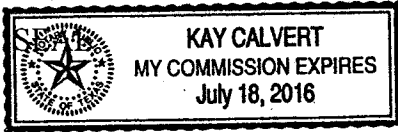
