On June 11, 2013, an Order for Fred Jason Beam was entered by the Eligibility & Disciplinary Committee of the Texas Board of Nursing (Committee). However, the Order contained a typographical error, in that it omitted the date of the public meeting from page 1 of the Order. Upon notice and hearing, administrative agencies, like the Courts, have the power to enter nunc pro tunc orders where it can be seen by reference to a record that what was intended to be entered, but was omitted by inadvertence or mistake, can be corrected upon satisfactory proof of its rendition provided that no intervening rights will be prejudiced. *Railroad Comm'n v. McClain*, 356 S.W.2d 330, 334 (Tex. App.--Austin 1962, no writ) (citing *Frankfort Ky. Nat. Gas Co. v. City of Frankfort*, 276 Ky. 199, 123 S.W.2d 270, 272).

The Executive Director, as agent of the Board, after review and due consideration of the record and the facts therein, invalidates the incorrect Order for Fred Jason Beam that omits the date of the Committee's public meeting and enters the corrected version of the Order, which reflects the date of the public meeting. Mr. Beam received due process regarding his license; therefore, his rights have not been prejudiced.

NOW, THEREFORE, IT IS ORDERED that the corrected Order is hereby approved and entered on the dates set forth below.

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, FRED JASON BEAM, is a Registered Nurse holding License Number 734011, which is in Current status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

CHARGE I.

On or about April 8, 2012, while working as a Agency RN with Medical Staffing Network, staffed through Atrium Medical Center, Corinth, Texas, Respondent withdrew 2 mg Dilaudid from the Medication Dispensing System at 7:49 am. 10:52 am, 14:46 pm and 17:57 pm for Patient Medical Record Number 100003019, but failed to completely and accurately document and/or administer the medication to the patient. Respondent's conduct was likely to injure patients in that subsequent care givers would rely on his documentation to further medicate the patient which could result in an overdose and placed the hospital in violation of Chapter 481 of the Texas Health and Safety Code (Controlled Substance Act).

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(13), Texas Occupations Code, and is a violation of 22 Tex. ADMIN. CODE \$217.11(1)(A),(1)(B),(1)(C)&(1)(D), and 22 Tex. ADMIN. CODE \$217.12(1)(A),(1)(B),(1)(C)&(6)(G).

CHARGE IL.

On or about April 8, 2012, while working as a Agency RN with Medical Staffing Network, staffed through Atrium Medical Center, Corinth, Texas, Respondent misappropriated Dilaudid or failed to take precautions to prevent the misappropriation of Dilaudid from the facility and the patients thereof. Respondent's conduct defrauded the facility and the patients thereof of the cost of the medications.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(13), Texas Occupations Code, and is a violation of 22 Tex. ADMIN. CODE §217.11(1)(A) and 22 Tex. ADMIN. CODE §217.12(1)(A),(1)(B),(1)(C)&(6)(G).

CHARGE III.

On or about December 5, 2012, Respondent was arrested by the Garland Police Department, Garland, Texas, for AGGRAVATED ASSAULT/FAMILY/HOUSE W/WEAPON a 2ND DEGREE FELONY. Respondent's conduct was likely to injure patients or the public.

NOTICE IS GIVEN that staff will present evidence in support of the recommended disposition of up to, and including, revocation of Respondent's license/s to practice nursing in the State of Texas pursuant to the Nursing Practice Act, Chapter 301, Texas Occupations Code and the Board's rules, 22 Tex.
