Respondent waived representation by counsel, informal proceedings, notice and

hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Respondent is currently licensed to practice professional nursing in the State of Texas. Respondent holds a license to practice vocational nursing in the State of Texas which is currently in delinquent status.
- 2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
- 3. Respondent received a Certificate in Vocational Nursing from Howard College, Big Spring, Texas, on August 25, 1977; and received an Associate Degree in Nursing from Angelo State University, San Angelo, Texas, on May 1, 1981. Respondent was licensed to practice vocational nursing in the State of Texas on November 22, 1977; and was licensed to practice professional nursing in the State of Texas on September 8, 1981.

On or about September 21, 2007, Respondent was issued a REMEDIAL EDUCATION Order by the Board of Nurse Examiners for the State of Texas, Austin, Texas. A copy of the Findings of Fact, Conclusions of Law, and Agreed Order dated September 21, 2007, is attached and incorporated, by reference, as part of this Order.

- 6. On or about March 20, 2013, while employed with San Angelo State Supported Living Center, San Angelo, Texas, Respondent failed to utilize the mechanical lift for Patient Number 951, who was non-weight bearing with severe arthritis, as directed in the Physical/Nutritional Management Plan. Instead, Respondent placed her arms under the arms of the patient and lifted him from his wheelchair. Respondent's conduct unnecessarily exposed the patient to risk of injury and pain from improper patient handling.
- 8. On October 22, 2014, the Board received a notarized statement from Respondent voluntarily surrendering the right to practice nursing in Texas. A copy of Respondent's notarized statement, dated October 20, 2014, is attached and incorporated herein by reference as part of this Order.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.11(1)(A)&(B) and 22 TEX. ADMIN. CODE §217.12(1)(A),(1)(B),(4)&(6)(C).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 254824, and Vocational Nurse License Number 73611, heretofore issued to BRENDA S HAMNER, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
- 5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
- 6. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
- 7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 TAC§§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Registered

Nurse License Number 254824, and Vocational Nurse License Number 73611, heretofore issued to BRENDA S HAMNER, to practice nursing in the State of Texas, is/are accepted by the Executive

Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board

imposes the following conditions:

- 1. RESPONDENT SHALL NOT practice professional or vocational nursing, use the title of "registered nurse" or "vocational nurse" or the abbreviation RN or LVN or wear any insignia identifying herself as a registered nurse or vocational nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a/an registered nurse or vocational nurse during the period in which the license/s is/are surrendered.
- 2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
- 3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable

to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

Information received by the Board produced evidence that Respondent may have

violated Section 301.452(b)(10) & (13), Texas Occupations Code. Respondent waived representation

by counsel, informal conference, notice and hearing, and agreed to the entry of this Order offered on

August 9, 2007, by Katherine A. Thomas, MN, RN, Executive Director.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
- 2. Respondent waived representation by counsel, informal conference, notice and hearing, and agreed to the entry of this Order.
- 3.` Respondent is currently licensed to practice professional nursing in the State of Texas and holds a license to practice vocational nursing which is in Delinquent status.
- 4. Respondent received a Certificate in Vocational Nursing from Vocational Nursing School, San Angelo, Texas, on August 25, 1977, and received an Associate Degree in Nursing from Angelo State University, San Angelo, Texas, on May 1, 1981. Respondent was licensed to practice vocational nursing in the State of Texas on November 22, 1977, and to practice professional nursing in the State of Texas on September 8, 1981.

6. At the time of the incident in Finding of Fact Number Seven (7), Respondent was employed as a Staff Nurse with San Angelo State School, San Angelo, Texas, and had been in this position for twelve (12) years and nine (9) months.

- 7. On or about April 13, 2006, while employed with San Angelo State School, San Angelo, Texas, Respondent failed to institute the appropriate nursing interventions for Consumer BK, who experienced a significant cardiac event, had stopped breathing, was without pulse, and subsequently died. Although Respondent initiated cardiopulmonary resuscitation (CPR), she declined the use of an Automated External Defibrillator (AED), when offered by her supervisor. Respondent's conduct deprived the patient of early detection of a significant cardiac event and emergent treatment by application of electrical therapy which would have allowed the heart to re-establish an effective rhythm, and may have prevented the patient's demise.
- 8. Respondent states that when her supervisor asked her if she needed the AED she declined because she didn't know what he meant. In retrospect, Respondent states that she can see how she erred not using the AED immediately and realized this as soon as the event was over. Respondent states that this mistake was due to the stress she was feeling, her previous experiences with actual codes before AEDs were a part of the process and the lapse of time since she had taken a CPR class.
- 9. Respondent completed a CPR and Basic Cardiac Life Support (BCLS) on May 5, 2006, which would have been a requirement of this Order.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation of Section 301.452(b)(10) & (13), Texas Occupations Code, 22 TEX. ADMIN. CODE §217.11(1)(B)&(M) and 22 TEX. ADMIN. CODE §217.12(4).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 73611 and Registered Nurse License Number 254824, heretofore issued to BRENDA S. HAMNER, including revocation of Respondent's licenses to practice vocational and professional nursing in the State of Texas.

<u>ORDER</u>

IT IS THEREFORE AGREED and ORDERED, subject to ratification by the Board of Nurse Examiners, that RESPONDENT SHALL receive the sanction of REMEDIAL EDUCATION, and RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Revised Civil Statutes of Texas as amended, Texas Occupations Code §§301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.01 *et seq.* and this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privilege, if any, to practice professional and vocational nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the State of Texas and the Board of

Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED that:

(1) RESPONDENT SHALL deliver the wallet-sized license issued to BRENDA S. HAMNER to the office of the Board of Nurse Examiners within ten (10) days of the date of ratification of this Order for appropriate notation.

(2) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in Texas nursing jurisprudence and ethics. RESPONDENT SHALL obtain Board approval of the course prior to enrollment only if the course is not being offered by a pre-approved provider. Home study courses and video programs will not be approved. In order for the course to be approved, the target audience shall include nurses. It shall be a minimum of six (6) contact hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding Sexual Misconduct, Fraud, Theft and Deception, Nurses with Chemical Dependency, and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. RESPONDENT SHALL CAUSE the sponsoring institution to submit a Verification of Course Completion form, provided by the Board, to the Office of the Board to verify RESPONDENT's successful completion of the course. This course shall be taken in addition to any other courses stipulated in this Order, if any, and in addition to any continuing education requirements the Board has for relicensure. (3) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in "Sharpening Critical Thinking Skills," a 3.6 contact hour online program

In order to receive credit for completion of this program, RESPONDENT SHALL SUBMIT the continuing education certificate of completion for this program to the Board's office, to the attention of Monitoring. IT IS FURTHER AGREED, that upon full compliance with the terms of this Order, RESPONDENT SHALL be issued an unencumbered license and multistate licensure privileges, if any, to practice vocational nursing in the State of Texas.
