On this day the Texas Board of Nursing, hereinafter referred to as the Boarc considered the matter of JOE LUIS RAMIREZ, Vocational Nurse License Number 169699, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may be subject to discipline pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code. Respondent waived notice and hearing and agreed to the entry of this Order approved by Katherine A. Thomas, MN, RN, FAAN, Executive Director, on September 5, 2014.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived notice and hearing, and agreed to the entry of this Order.
- 3. Respondent's license to practice as a vocational nurse in the State of Texas is in current status.
- 4. Respondent received a Certificate in Vocational Nursing from Del Mar College, Corpus Christi, Texas, on August 19, 1998. Respondent was licensed to practice vocational nursing in the State of Texas on October 14, 1998.
- 5. Respondent's nursing employment history includes:

6. At the time of the incident, Respondent was employed as a Licensed Vocational Nurse (LVN) with American Habilitation Services, Inc., Corpus Christi, Texas, and had been in that position for seven (7) years and three (3) months.

- 7. On or about June 20, 2011 through August 6, 2011, while employed with American Habilitation Services, Inc., Corpus Christi, Texas, Respondent practiced outside his scope as a LVN when providing care for Patient R. D. I. in that Respondent performed comprehensive assessments which were used to generate the Individual Plan of Care (IPC) hours for nursing services and he delegated medication administration which is required to be done by a registered nurse according to policy of Home and Community Based Services (HCS) Program. Respondent's conduct was likely to injure the patient from medical complications due to medical care he performed without sufficient training and that may have been inadequate, unsafe, and non-efficacious.
- 8. In response to Finding of Fact Number Seven (7), Respondent denies that he ever completed the RN delegation forms for any staff. He attended the yearly meetings and the team would agree on the care and medical needs for the patient for the upcoming year. As the nurse he would decide how many units he would need as the LVN to provide care. No full time RN was available, the agency had a contract RN who would complete the assessments, RN delegations and RN Chart review. As the program nurse he also completed the SAM's assessment yearly.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.11(1)(A),(1)(B),(1)(T)&(2) and 22 TEX. ADMIN. CODE §217.12(1)(A),(1)(B),(1)(E) &(4).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 169699, heretofore issued to JOE LUIS RAMIREZ.

from RESPONDENT'S license(s) to practice nursing in the State of Texas and RESPONDENT may

be eligible for nurse licensure compact privileges, if any.


RESPONDENT'S CERTIFICATION
