FORMAL CHARGES

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, JARED CLAYTON TRUE, is a Vocational Nurse holding License Number 219232, which is in delinquent status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

CHARGE I.

On or about January 23, 2014, while employed as a Licensed Vocational Nurse/Jail Nurse with the Jacksonville Sheriff's Office Medical Services Division, Jacksonville, Florida, Respondent was arrested by the Jacksonville County Sheriff's Office Integrity Unit for CHILD ABUSE, a felony offense committed on January 7, 2014, and AGGRAVATED BATTERY ON A PREGNANT WOMAN, a felony offense committed on or about October 1, 2013. The charges were subsequently filed under State Attorney Case No. 14CF003670AD, and on or about February 20, 2014, Respondent was accepted into the Kids in Distress Diversion Program.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10), Texas Occupations Code, and is a violation of 22 Tex. ADMIN. CODE §217.12(6)(C)&(13).

NOTICE IS GIVEN that staff will present evidence in support of the recommended disposition of up to, and including, revocation of Respondent's license/s to practice nursing in the State of Texas pursuant to the Nursing Practice Act, Chapter 301, Texas Occupations Code and the Board's rules, 22 Tex. Admin. Code §§ 213.27 - 213.33 and Tex. Occ. Code Ch. 53. Additionally, staff will seek to impose on Respondent the administrative costs of the proceeding pursuant to Section 301.461, Texas Occupations Code. The cost of proceedings shall include, but is not limited to, the cost paid by the Board to the State Office of Administrative Hearings and the Office of the Attorney General or other Board counsel for legal and investigative services, the cost of a court reporter and witnesses, reproduction of records, Board staff time, travel, and expenses. These shall be in an amount of at least one thousand two hundred dollars (\$1200.00).
