

ORDER OF THE BOARD

On this day, the Texas Board of Nursing, hereinafter referred to as the Board, accepted the voluntary surrender of Registered Nurse License Number 544381, and Vocational Nurse License Number 80056, issued to MARK R HAMMEL, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Respondent is currently licensed to practice professional nursing in the State of Texas. Respondent's license to practice vocational nursing in the State of Texas is in delinquent status.
- 2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
- 3. Respondent received a Certificate in Vocational Nursing from Southwestern College, Chula Vista, California, on December 21, 1977; and received a Baccalaureate Degree in Nursing from University of Texas at Arlington, Arlington, Texas, on August 21, 1987. Respondent was licensed to practice vocational nursing in the State of Texas on April 11, 1979, and was licensed to practice professional nursing in the State of Texas on March 29, 1988.
- 4. Respondent's nursing employment history includes:

- 5. On or about January 1, 2013, through January 17, 2013, while employed as a Registered Nurse with Plaza Medical Center, Fort Worth, Texas, Respondent withdrew Morphine, Fentanyl, Dilaudid, and Hydrocodone from the medication dispensing system for patients, but failed to follow the policy and procedure for the wastage of the unused portions of the medications. Respondent's conduct left medications unaccounted for, was likely to deceive the hospital pharmacy, and placed the pharmacy in violation of Chapter 481 (Controlled Substances Act) of the Texas Health and Safety Code.
- 6. On or about January 1, 2013, through January 17, 2013, while employed as a Registered Nurse with Plaza Medical Center, Fort Worth, Texas, Respondent misappropriated Morphine, Fentanyl, Dilaudid, and Hydrocodone belonging to the facility and patients thereof, or failed to take precautions to prevent such misappropriation. Respondent's conduct was likely to defraud the facility and patients, thereof, of the cost of the medications, and is a violation of Chapter 481 (Controlled Substances Act) of the Texas Health and Safety Code.
- 7. On or about January 1, 2013, through January 17, 2013, while employed as a Registered Nurse with Plaza Medical Center, Fort Worth, Texas, Respondent withdrew Morphine, Fentanyl, Dilaudid, and Hydrocodone from the Medication Dispensing System for a patient in excess frequency/dosage of physicians' orders. Respondent's conduct was likely to injure the patient in that the administration of medication in excess dosage of the physicians' orders could result in the patient suffering from adverse reactions, and is in violation of Chapter 481 (Controlled Substances Act) of the Texas Health and Safety Code.

- 8. On or about January 7, 2013, while employed as a Registered Nurse with Plaza Medical Center, Fort Worth, Texas, Respondent engaged in the intemperate use of Morphine, Hydromorphone, Fentanyl, Norfentanyl, and Hydrocodone, in that he produced a specimen for a drug screen that resulted positive for Morphine, Hydromorphone, Fentanyl, Norfentanyl, and Hydrocodone. Unlawful possession of Morphine, Hydromorphone, Fentanyl, Norfentanyl, and Hydrocodone is prohibited by Chapter 481 (Controlled Substances Act) of the Texas Health & Safety Code. The use of Morphine, Hydromorphone, Fentanyl, Norfentanyl, and Hydrocodone by a Registered Nurse, while subject to call or duty, could impair the nurse's ability to recognize subtle signs, symptoms, or changes in a patient's condition, and could impair the nurse's ability to make rational, accurate, and appropriate assessments, judgments, and decisions regarding patient care, thereby placing a patient in potential danger.
- 9. On or about January 23, 2013, Respondent was referred to the Texas Peer Assistance Program for Nurses (TPAPN) for drug use, and subsequently signed a Participation Agreement on January 29, 2013. On or about February 19, 2014, while participating in TPAPN, Respondent submitted to a urine drug screen with a temperature that did not register (cold urine sample), and as a result, Respondent restarted his participation with TPAPN on March 4, 2014. In addition, on May 12, 2014, TPAPN was notified by his employer that he had been terminated for multiple medication errors and for attempting to access the pyxis while another nurse was signed in to system, which were violations of his narcotic restriction. Consequently, due to his noncompliance, TPAPN closed his case and referred him to the Texas Board of Nursing.
- 10. On or about May 8, 2014, while employed as a Registered Nurse with Promise Hospital of Dallas, Dallas, Texas, Respondent attempted to access the Pyxis while another nurse was signed in to the system. Respondent's conduct was likely to deceive the pharmacy and is a violation of Chapter 481 (Controlled Substances Act) of the Texas Health and Safety Code.
- 11. On April 13, 2015, the Board received a notarized statement from Respondent voluntarily surrendering the right to practice nursing in Texas. A copy of Respondent's statement, dated April 10, 2015, is attached and incorporated herein by reference as part of this Order.
- 12. The Board policy implementing Rule 213.29 in effect on the date of this Agreed Order provides discretion by the Executive Director for consideration of conditional reinstatement after proof of twelve (12) consecutive months of abstinence from alcohol and drugs followed by licensure limitations/stipulations and/or peer assistance program participation.
- 13. The Board finds that there exists serious risks to public health and safety as a result of impaired nursing care due to intemperate use of controlled substances or chemical dependency.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 Tex. ADMIN. CODE §217.11(1)(A),(1)(B),(1)(C)&(1)(D) and 22 Tex. ADMIN. CODE §217.12(1)(A),(1)(B),(1)(E),(4),(5),(6)(G),(8),(10)(A),(10)(C),(10)(D),(10)(E)&(11)(B).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(9),(10)&(13), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 544381, and Vocational Nurse License Number 80056, heretofore issued to MARK R HAMMEL, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
- 5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
- 6. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
- 7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 TAC§§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Registered Nurse License Number 544381, and Vocational Nurse License Number 80056, heretofore issued to MARK R HAMMEL, to practice nursing in the State of Texas, are accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

- 1. RESPONDENT SHALL NOT practice professional nursing, use the title of "registered nurse" or "vocational nurse" or the abbreviation "RN" or "LVN" or wear any insignia identifying himself as a registered nurse or vocational nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the licenses are surrendered.
- 2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order; and, RESPONDENT has obtained objective, verifiable proof of twelve (12) consecutive months of sobriety immediately preceding the petition.
- 3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.
