ORDER

On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of TIAISHIA TARQUELE ROLLINS, Registered Nurse License Number 799523, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may be subject to discipline pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code. Respondent waived notice and hearing and agreed to the entry of this Order approved by Katherine A. Thomas, MN, RN, FAAN, Executive Director, on June 16, 2015.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived notice and hearing, and agreed to the entry of this Order.
- 3. Respondent's license to practice as a professional nurse in the State of Texas is in TX-INVALID status.
- 4. Respondent received an Associate Degree in Nursing from Meridian Community College, Meridian, Mississippi, on December 15, 2007, and received a Bachelor of Science Degree in Nursing from Union University, Germantown, Tennessee, in December 2010. Respondent was licensed to practice professional nursing in the State of Texas on April 5, 2011.

- 6. At the time of the initial incident, Respondent was employed as a Registered Nurse with Pulse Staffing Agency, Houston, Texas, and had been in that position for two (2) years.
- 7. On or about, December 12, 2012, through December 13, 2012, while employed with Pulse Staffing, Houston, Texas, and assigned to Emerus, Sugarland, Texas, Respondent falsely documented taking vital signs, changing the patient's bedding, and assessing the patient throughout the night, in the medical record of Patient 1037396. Security video of the patient in his room shows Respondent coming in and out of the patient's room but at no time are vital signs taken or a stethoscope seen being used on the patient. Respondent's conduct was deceptive and was likely to injure the patient in that subsequent care givers would rely on her documentation to provide further care.
- 8. In response to Finding of Fact Number Seven (7), Respondent states she gave the patient the best care possible while following all the guidelines defined under Emerus's Registered Nurse job duties and the Board of Nursing.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 Tex. ADMIN. CODE §§217.11(1)(A),(1)(B)&(1)(D) and 217.12(1)(A),(1)(B),(1)(C),(4)&(6)(A).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 799523, heretofore issued to TIAISHIA TARQUELE ROLLINS.

5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.

TERMS OF ORDER

I. SANCTION AND APPLICABILITY

IT IS THEREFORE AGREED and ORDERED that RESPONDENT SHALL receive the sanction of **WARNING WITH STIPULATIONS** and Respondent's license(s) shall be placed in **INACTIVE** status.

Should RESPONDENT decide in the future to reactivate his/her license(s) to practice nursing in the State of Texas, RESPONDENT SHALL be required to satisfy all then existing requirements for reactivation and RESPONDENT'S reactivated license(s) SHALL BE subject to, at a minimum, the remedial education courses, work restrictions, supervised practice, and employer reporting which would have been requirements of this Order had Respondent not chosen to inactivate his/her nursing license(s).
