AGREED BOARD ORDER

On this day came on to be considered by the Board of Vocational Nurse Examiners the matter of vocational nurse license number 115221 held by RAUL V. CARDENAS, hereinafter called Respondent.

By letter, the Board of Vocational Nurse Examiners sent preliminary notice to Respondent of its intent to take disciplinary action with respect to said license held by Respondent as a result of a complaint and subsequent investigation. Said investigation produced evidence indicating that Respondent has violated the Vocational Nurse Act or rule, regulation or order issued under the Act, contrary to Article 4528c, Section 10 (a) (1), Revised Civil Statutes of Texas, in the following manner:

- a. On September 15, 1986, the Board of Vocational Nurse Examiners endorsed an Agreed Board Order allowing Respondent to write the examination for licensure and that upon passing said examination Respondent would be issued a license.
- b. Said Order further stipulated that said license be suspended, suspension stayed and placed on probation for a period of one (1) year, and that Respondent cause his nursing employer to submit satisfactory quarterly reports to the Board Office for the term of probation.
- c. Respondent has failed to submit said employer reports to the Board Office in a timely quarterly manner as ordered by the Board of Vocational Nurse Examiners on September 15, 1986.

By Respondent's signature on this Order, Respondent neither admits nor denies the truth of the matters previously set out in this Order with respect to the above mentioned investigation.

By his signature on this Order Respondent does hereby waive the right to Notice of a Formal Hearing, and a Formal Hearing before the Board of Vocational Nurse Examiners, and to judicial review of this disciplinary action. Notice of this disciplinary action will appear in the Board's newsletter sent to Texas employers.

ORDER OF THE BOARD

THEREFORE, PREMISES CONSIDERED, The Board of Vocational Nurse Examiners does hereby order that RAUL V. CARDENAS, license number 115221, be suspended, suspension stayed and placed on probation for a period of six (6) months. It is further ordered that Respondent will cause his nursing employer to submit satisfactory quarterly reports to the Board Office for the term of probation.

Furthermore, if the place of employment, or Respondent's address or telephone number changes, the Board is to be notified immediately.

It is also ordered that RAUL V. CARDENAS shall comply with all the provisions of Article 4528c, Revised Civil Statutes of Texas.

This Agreed Order shall not be effective or take effect and become enforceable until endorsed by a majority of the Board (present and voting), at its next regularly called session.
