On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of JUMOKE JELILAT MAJEKODUNMI, Vocational Nurse License Number 318568, hereinafter referred to as Respondent.

This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived notice and hearing and agreed to the entry of this Order.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived notice and hearing, and agreed to the entry of this Order.
- 3. Respondent's license to practice as a vocational nurse in the State of Texas is in current status.
- 4. Respondent received a Certificate in Vocational Nursing from Americare Technical School, Chicago, Illinois, on April 1, 2010. Respondent was licensed to practice vocational nursing in the State of Texas on January 31, 2014.
- 5. Respondent's nursing employment history includes:

6. At the time of the initial incident, Respondent was employed as a Licenced Vocational Nurse with Vitas Innovative Hospice Care, Dallas, Texas, and had been in that position for approximately six (6) months.

- 7. On or about November 16, 2014, while employed as a Licensed Vocational Nurse with Vitas Healthcare, Dallas, Texas, and assigned to provide nursing care to Patient HH, Respondent lacked fitness to practice vocational nursing, in that she was witnessed sleeping while on duty. Respondent's conduct could have affected her ability to recognize subtle signs, symptoms or changes in patients' conditions, and could have affected her ability to make rational, accurate, and appropriate assessments, judgments, and decisions regarding patient care, thereby placing the patients in potential danger.
- 8. On or about February 2, 2015, while employed as a Licensed Vocational Nurse with Vitas Healthcare, Dallas, Texas, and assigned to provide nursing care to Patient RB, Respondent lacked fitness to practice vocational nursing, in that she was witnessed sleeping while on duty. Respondent's conduct could have affected her ability to recognize subtle signs, symptoms or changes in patients' conditions, and could have affected her ability to make rational, accurate, and appropriate assessments, judgments, and decisions regarding patient care, thereby placing the patients in potential danger.
- 9. On or about May 25, 2015, while employed as a Licensed Vocational Nurse with Vitas Healthcare, Dallas, Texas, and assigned to provide nursing care to Patient SV, Respondent lacked fitness to practice vocational nursing, in that she was witnessed sleeping while on duty. Respondent's conduct could have affected her ability to recognize subtle signs, symptoms or changes in patients' conditions, and could have affected her ability to make rational, accurate, and appropriate assessments, judgments, and decisions regarding patient care, thereby placing the patients in potential danger.
- 10. In response to Findings of Fact Numbers Seven (7) through Nine (9), Respondent states that she did not sleep while on duty. In regards to November 16, 2014, Respondent states Patient

HH's daughter tip-toed into the area where she was caring for the patient three (3) times over the course of the shift, hoping to find Respondent asleep. In regards to February 2, 2015, Respondent states Patient RB's spouse insisted Respondent stay in the living room. Respondent believes the patient called out, but she did not hear him because of the distance and his low tone. Respondent states the patient awoke his spouse, who became irritated, and she assumed Respondent could not hear the patient because she had been sleeping. In regards to May 25, 2015, Respondent states she did not hear Patient SV's daughter call her because she had an ear piece in.

- 11. Formal Charges were filed on November 3, 2015.
- 12. Formal Charges were mailed to Respondent on November 6, 2015.
- 13. Respondent, by her signature to this Order, expresses her desire to voluntarily surrender her license to practice nursing in the State of Texas.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 Tex. ADMIN. CODE §217.11(1)(B), and 22 Tex. ADMIN. CODE §217.12(1)(A),(1)(B),(1)(E),(4)&(5).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10),(12)&(13), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 318568, heretofore issued to JUMOKE JELILAT MAJEKODUNMI, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
- 5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.
- 6. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
- 7. Under Section 301.453(d), Texas Occupations Code, as amended, the Board may impose conditions for reinstatement of licensure.
- 8. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 Tex. Admin. Code §213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

TERMS OF ORDER

NOW, THEREFORE, IT IS AGREED and ORDERED that the **VOLUNTARY SURRENDER** of Vocational Nurse License Number 318568, heretofore issued to JUMOKE
JELILAT MAJEKODUNMI, to practice nursing in the State of Texas, is accepted by the Texas
Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

- 1. RESPONDENT SHALL NOT practice vocational nursing, use the title "vocational nurse" or the abbreviation "LVN" or wear any insignia identifying herself as a vocational nurse, or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a vocational nurse during the period in which the license is surrendered.
- 2. RESPONDENT SHALL NOT petition for reinstatement of licensure until one (1) year has elapsed from the date of this Order.
- 3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.
