xecutive Director of the Board issued to CYNTHIA ANN FRY OKROJ ORDER An investigation by the Texas Board of Nursing, hereinafter referred to as the Board, produced evidence indicating that CYNTHIA ANN FRY OKROJ, Registered Nurse License Number 515319, hereinafter referred to as Respondent, may be subject to discipline pursuant to

An informal conference was conducted on July 26, 2016, in accordance with Section 301.464. Texas Occupations Code. Respondent appeared in person. Respondent was represented by Noelle C. Letteri, Attorney at Law.

This action was taken in accordance with Section 301.453(c), Texas Occupations Code. The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- Prior to the institution of Agency proceedings, notice of the matters specified below in these 1. Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- Respondent waived notice and hearing, and agreed to the entry of this Order. 2.
- Respondent's license to practice as a professional nurse in the State of Texas is in current 3. status.
- Respondent received a Baccalaureate Degree in Nursing from the University of Delaware, 4. Newark, Delaware, on June 1, 1975, and received a Master's Degree in Nursing from the University of Texas at Austin, Austin, Texas, in 1985. Respondent was licensed to practice professional nursing in the State of Texas on July 9, 1984.

- 6. At the time of the initial incident, Respondent was employed as the Owner and CEO of Bon Accord Allergy and Wellness LLC, Lago Vista, Texas, and had been in that position for one (1) year and two (2) months.
- On or about January 19, 2015, through April 15, 2015, while employed as the Owner and CEO of Bon Accord Allergy and Wellness LLC, Lago Vista, Texas, and licensed as a Registered Nurse, Respondent failed to recognize that Patient JP was showing signs and symptoms suggestive of medical and/or mental health disorders that required referral to medical and/or psychiatric practitioners, and instead continued treating the patient holistically. The patient described physical complaints of blurred vision, jerking/buzzing sensations, shaking, feeling physically ill, pain in her back and arm; expressed concerns that her life was in danger; and described continued audio and visual hallucinations. The patient was subsequently diagnosed by medical providers with a brain tumor. Respondent's conduct was likely to injure the patient from a delay in appropriate medical diagnosis and treatment.
- In response to the incident in Finding of Fact Number Seven (7), Respondent states that she 8. is not providing any medical treatment, but her services focus on energy healing known as the Emotion Code and the Body Code System, meant to balance the body's energy, relieve stress, and support the body's natural ability to heal. Respondent adds that when she first meets with clients, she provides them with client information including documents the clients sign attesting that they understand that the sessions are not meant to replace treatment by established medical practice but to complement them. Regarding JP, Respondent states that she provided services to JP on a regular basis, initially for difficulties sleeping and later for left arm and leg pain, until mid-March 2015. Respondent states that JP reported feeling relief after the sessions. Respondent states that when JP reported blurred vision, she suggested that the patient have her vision checked. Respondent states that on April 2, 2015, JP called Respondent from Houston, where she had moved to receive conventional medical and pastoral care, and they spoke on the phone and emailed four (4) times during April. Respondent states that JP informed her that the medical doctors had found "spots on her right lower brain" and were suggesting surgery. Respondent states that on June 7, 2015, JP reported that she was on medications, and Respondent provided services to her two (2) more times in late June via email, through July 5, 2015, which was the last contact they had together.
- 9. Respondent, by her signature to this Order, expresses her desire to voluntarily surrender her license to practice nursing in the State of Texas.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.

- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 Tex. ADMIN. CODE §§§217.10 (a)(9), 217.11(1)(A),(1)(B),(1)(M),(1)(P),(1)(Q)&(3)(A) and 217.12(1)(A),(1)(B)&(4).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(1),(10)&(13), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 515319, heretofore issued to CYNTHIA ANN FRY OKROJ, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
- 5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.
- 6. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
- 7. Under Section 301.453(d), Texas Occupations Code, as amended, the Board may impose conditions for reinstatement of licensure.
- 8. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 Tex. ADMIN. CODE §213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

TERMS OF ORDER

NOW, THEREFORE, IT IS AGREED and ORDERED that the VOLUNTARY SURRENDER of Registered Nurse License Number 515319, heretofore issued to CYNTHIA ANN FRY OKROJ, to practice nursing in the State of Texas, is accepted by the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

- 1. RESPONDENT SHALL NOT practice professional/registered nursing, use the title "registered nurse" or the abbreviation "RN" or wear any insignia identifying herself/himself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
- 2. RESPONDENT SHALL NOT petition for reinstatement of licensure until at least one (1) year has elapsed from the date of this Order.
- 3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then

existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.
