On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of DEBRA LORRAINE JAMES, Registered Nurse License Number 595295, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may be subject to discipline pursuant to Section 301.452(b)(10), Texas Occupations Code. Respondent waived notice and hearing and agreed to the entry of this Agreed Order approved by Katherine A. Thomas, MN, RN, FAAN, Executive Director, on March 28, 2019.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived notice and hearing, and agreed to the entry of this Agreed Order.
- 3. Respondent's license to practice as a professional nurse in the State of Texas is in nurse licensure compact invalid status.
- 4. Respondent received an Associate Degree in Nursing from Tarleton State University, Stephenville, Texas, on May 15, 1993. Respondent was licensed to practice professional nursing in the State of Texas on September 22, 1993.

^{6.} At the time of the incident, Respondent was employed as a Registered Nurse with Mirror Lake Recovery Center, Burns, Tennessee, and had been in that position for two (2) months.

- 7. On or about October 29, 2018, while utilizing a Privilege to Practice (PTP) nursing from the State of Texas and employed with Mirror Lake Recovery Center, Burns, Tennessee, Respondent failed to take the precautions to secure two (2) Phenobarbital 60mg tablets belonging to the facility and patients thereof in that, Respondent's end of shift medication count was initially off by two (2) Phenobarbital 60mg tablets before Respondent retrieved one (1) Phenobarbital 60mg tablet from her pocket. Additionally, Respondent was the only person with keys to the medication cart. Respondent's conduct was likely to defraud the facility and patients thereof of the cost of the medications.
- .8. In response to Finding of Fact Number Seven (7), Respondent states she made an error in which the facility embellished. Additionally, Respondent relates she found a pill on top of the medication cart and willingly told the facility she made an error in the count and that she held onto the pill until there was time to properly identify it.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.11 (1)(A)&(1)(B) and 22 TEX. ADMIN. CODE §217.12 (1)(A),(1)(B)&6(G).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 595295, heretofore issued to DEBRA LORRAINE JAMES.
- 5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.

TERMS OF ORDER

I. SANCTION AND APPLICABILITY

IT IS THEREFORE AGREED and ORDERED that RESPONDENT SHALL receive the sanction of **REMEDIAL EDUCATION** and RESPONDENT'S license(s) shall be placed in **INACTIVE** status.

Should RESPONDENT decide in the future to reactivate her license to practice nursing in the State of Texas, RESPONDENT SHALL be required to petition the Board for reactivation of the license and satisfy all then existing requirements for reactivation. Further, RESPONDENT'S reactivated license SHALL BE subject to, at a minimum, the remedial education courses which would have been requirements of this Order had RESPONDENT not chosen to inactivate her nursing license.

II. SUBSEQUENT CRIMINAL PROCEEDINGS

IT IS FURTHER AGREED, should the RESPONDENT'S conduct, as outlined in the findings of fact of this Agreed Order, result in subsequent judicial action, including a deferred disposition, RESPONDENT may be subject to further disciplinary action, up to, and including, revocation of RESPONDENT'S license(s) to practice nursing in the State of Texas.
