On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of ELENA B CANTU, Vocational Nurse License Number 64876, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may be subject to discipline pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code.

Respondent waived notice and hearing and agreed to the entry of this Agreed Order approved by Katherine A. Thomas, MN, RN, FAAN, Executive Director, on April 29, 2019.

FINDINGS OF FACT

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived notice and hearing, and agreed to the entry of this Agreed Order.
- 3. Respondent's license to practice as a vocational nurse in the State of Texas is in current status.
- 4. Respondent received a Certificate in Vocational Nursing from Del Mar Tech Institute Vocational, Corpus Christi, Texas, on April 30, 1975. Respondent was licensed to practice vocational nursing in the State of Texas on October 23, 1975.

6. At the time of the initial incident, Respondent was employed as a Licensed Vocational Nurse (LVN) with All About Kids, Harlingen, Texas, and had been in that position for one (1) month.

- 7. On or about October 22, 2018, while employed as a Licensed Vocational Nurse (LVN) with All About Kids Home Health, Harlingen, Texas, Respondent improperly transferred Patient JQ from his stander to his bed by unbuckling the chest area before unbuckling the leg brace. As a result, Patient JQ slid down to the right and sustained a fracture to his right femur. Additionally, Respondent failed to report the incident to the patient's case manager and/or physician. Respondent's conduct contributed to the patient's injury, and deprived the physician and/or case manager of information needed to institute timely medical interventions.
- 8. In response to Finding of Fact Number Seven (7), Respondent admits she transferred the patient incorrectly, but states it was because she wasn't properly trained. Respondent further states she plans of retiring soon.

CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.11(1)(A),(1)(B),(1)(D)&(1)(P) and 22 TEX. ADMIN. CODE §217.12(1)(A),(1)(B) &(4).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 64876, heretofore issued to ELENA B CANTU.
- 5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.

TERMS OF ORDER

I. SANCTION AND APPLICABILITY

IT IS THEREFORE AGREED and ORDERED that RESPONDENT SHALL receive the sanction of **REPRIMAND WITH STIPULATIONS** and RESPONDENT'S license(s) shall be placed in **INACTIVE** status.

Should RESPONDENT decide in the future to reactivate his/her license(s) to practice nursing in the State of Texas, RESPONDENT SHALL be required to petition the Board for reactivation of the license and satisfy all then existing requirements for reactivation. Further, RESPONDENT'S reactivated license(s) SHALL BE subject to, at a minimum, the remedial education courses, work restrictions, supervised practice, and employer reporting which would have been requirements of this Order had RESPONDENT not chosen to inactivate his/her nursing license(s).
