On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of EARNESTINE YVONNE SAYLES, Vocational Nurse License Number 223324, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may be subject to discipline pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code.

Respondent waived notice and hearing and agreed to the entry of this Agreed Order approved by Katherine A. Thomas, MN, RN, FAAN, Executive Director, on April 23, 2019.

# **FINDINGS OF FACT**

- 1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license(s).
- 2. Respondent waived notice and hearing, and agreed to the entry of this Agreed Order.
- 3. Respondent's license to practice as a vocational nurse in the State of Texas is in nurse licensure compact invalid status.
- Respondent received a Certificate in Vocational Nursing from Hinds Community College
   Jackson, Jackson, Mississippi, on August 1, 2008. Respondent was licensed to practice
  vocational nursing in the State of Texas on August 27, 2009.
- 5. Respondent's nursing employment history includes:

- 6. At the time of the incident, Respondent was employed as a Licensed Vocational Nurse with Pediatric Home Healthcare, Dallas, Texas, and had been in that position for one (1) year.
- 7. On or about May 2, 2017, through June 22, 2017, while employed as a Licensed Vocational Nurse with Pediatric Home Healthcare, Dallas, Texas, and assigned to Patient H.O., Respondent falsely documented nursing notes for hours that were not worked and falsified Patient H.O.'s parent's signature on the nursing notes. Further, Respondent admitted to the Scheduler that she typically left the patient's home at 5:00 p.m. or 5:30 p.m., which did not match the check-out times documented on nursing notes. Respondent's conduct created an inaccurate medical record and was likely to defraud and deceive the patient or the public of money paid to Respondent for hours not actually worked.
- 8. In response to Findings of Fact Number Seven (7) Respondent states Patient H.O.'s mother gave her permission to sign her signature. Respondent states she documented the same check out time, even on the days she left early, because Patient H.O.'s mother told her to. Respondent states Patient H.O.'s mother didn't want the patient to lose nursing hours. Respondent states she did what she was told even though it was wrong.
- 9. Formal Charges were filed on February 8, 2019.

### **CONCLUSIONS OF LAW**

- 1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
- 2. Notice was served in accordance with law.
- 3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.11 (1)(A),(1)(B)&(1)(D) and 22 TEX. ADMIN. CODE §217.12 (1)(A),(1)(B),(1)(C),(4),(6)(A)&(6)(H).
- 4. The evidence received is sufficient cause pursuant to Section 301.452(b)(10)&(13), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 223324, heretofore issued to EARNESTINE YVONNE SAYLES.

5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.

# **TERMS OF ORDER**

#### I. SANCTION AND APPLICABILITY

IT IS THEREFORE AGREED and ORDERED that RESPONDENT SHALL receive the sanction of WARNING WITH STIPULATIONS and RESPONDENT'S license(s) shall be placed in INACTIVE status.

Should RESPONDENT decide in the future to reactivate his/her license(s) to practice nursing in the State of Texas, RESPONDENT SHALL be required to petition the Board for reactivation of the license and satisfy all then existing requirements for reactivation. Further, RESPONDENT'S reactivated license(s) SHALL BE subject to, at a minimum, the remedial education courses, work restrictions, supervised practice, and employer reporting which would have been requirements of this Order had RESPONDENT not chosen to inactivate his/her nursing license(s).
