ORDER GRANTING MODIFICATION

An Agreed Order of the Board was entered on October 25, 2018, for VICTOR MANUEL FALCON, Registered Nurse License Number 867675 and Vocational Nurse License Number 185568, hereinafter referred to as PETITIONER. PETITIONER filed a Request for Exception to the Agreed Order on August 5, 2019.

A public meeting of the Eligibility and Disciplinary Committee of the Board, hereinafter referred to as the Committee, was held on November 12, 2019, at 333 Guadalupe Street, Tower 3, Suite 460, Austin, Texas, to consider the Petition for Exception and supporting documents filed by PETITIONER.

PETITIONER appeared in person.

Board Members in attendance were: Allison Porter-Edwards, DrPH, MS, RN, CNE; David Saucedo, II; and Kimberly Wright, LVN.

After review and due consideration of the file petition, the Committee voted to delay the approval of the request until petitioner submitted adequate information from his employer. On November 14, 2019, Petitioner submitted the requested information.

IT IS THEREFORE ORDERED that Petitioner is required to comply with and complete all of the requirements of the October 25, 2018, Agreed Order, except that Stipulation(s) Number Five (V), Subsections I is added to the Order as follows:

I. Incident Reporting for current employer: While under the remaining terms of this Order, and employed with Monte Cristo Health Care, Inc., El Paso, Texas: PETITIONER SHALL CAUSE each employer to immediately submit any and all incident, counseling, variance, unusual occurrence, and medication or other error reports involving PETITIONER, as well as documentation of any internal investigations regarding action by PETITIONER, to the attention of Monitoring at the Board's office. While employed with Monte Cristo Health Care, Inc., El Paso, Texas, PETITIONER SHALL NOT be required to comply with Paragraphs C and G of this Order. However, should Petitioner's employment with Monte Cristo Health Care, Inc., El Paso, Texas, cease, PETITIONER SHALL BE required to comply with Paragraphs C and G for remainder of the Order, as applicable, for future employers.

Further, Paragraph H is modified as follows:

H. Nursing Performance Evaluations: While under the remaining terms of this Order, and employed with Monte Cristo Health Care, Inc., El Paso, Texas, PETITIONER SHALL CAUSE each employer to submit, on forms provided to the PETITIONER by the Board, periodic reports as to PETITIONER's capability to practice nursing. These reports shall be completed by the employer and submitted to the office of the Board at the end of each three (3) month quarterly period for the remaining period of the October 25, 2018, Order. However, should Petitioner's employment with Monte Cristo Health Care, Inc., El Paso, Texas, cease, PETITIONER SHALL be required to comply with Paragraph H, as applicable, for future employers.

All other terms and conditions of the October 25, 2018, Agreed Order remain unchanged and Petitioner is responsible for complying with those terms as written.
