AGREED BOARD ORDER

On this day came to be considered by the Board of Vocational Nurse Examiners the matter of vocational nurse license number 173407 held by GWENDOLYN LANELL GRANT, hereinafter called Respondent.

By letter, the Board of Vocational Nurse Examiners sent preliminary notice to Respondent of its intent to take disciplinary action with respect to said license held by Respondent, as a result of a complaint and subsequent investigation. Said investigation produced evidence indicating that Respondent has engaged in unprofessional or dishonorable conduct that, in the Board's opinion, is likely to deceive, defraud, or injure the public, in violation of Texas Occupations Code, Chapter 302, Section 302.402 (a) (10), in the following manner:

I.

- a. Respondent was employed as a licensed vocational nurse at Pittsburg Nursing Center, Pittsburg, Texas, from about December 29, 1999 to about April 17, 2001.
- b. While so employed at said facility, on or about October 1, 2000 through April 17, 2001, Respondent practiced vocational nursing while her license was in a delinquent status.

truth of the matters previously set out in this Order with respect to the above-mentioned

investigation. By Respondent's signature on this Order, Respondent acknowledges that

they have read and understood this Order and have approved it for consideration by the

Board.

By their notarized signature on this Order, Respondent does hereby waive the right to a

formal Complaint, Notice of Hearing and a Public Hearing held before an Administrative

Law Judge with the State Office of Administrative Hearings, and to judicial review of this

disciplinary action. Notice of this disciplinary action will appear in the Board's newsletter

sent to Texas employers.

ORDER OF THE BOARD

NOW THEREFORE, IT IS ORDERED that license number 173407, heretofore issued to

GWENDOLYN LANELL GRANT to practice vocational nursing in the State of Texas be,

and the same is hereby REPRIMANDED. It is further ordered that Respondent be

issued an administrative fine in the amount of \$ 250.00, said fine shall be in the form of a

cashier's check or money order, payable to the Board of Vocational Examiners. Said

fine shall be paid in monthly installments of \$ 50.00, due on the 30th of each month,

commencing the month following the date of the Boards ratification of this Order, and

continuing thereafter until the full amount of the fine has been paid. Said fee shall be

sent to the Board office, addressed to the "Board of Vocational Nurse Examiners", 333

Guadalupe, Suite 3-400, Austin, TX 78701.
