IT IS FURTHER ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, JANET ELIZA ALKIRE, is a Vocational Nurse holding license number 196136 which is in current status at the time of this pleading.

CHARGE I.

On or about June 7, 2021, Respondent entered a plea of Guilty to ABANDON ENDANGER CHILD CRIMINAL NEGLIGENCE, State Jail Felony offense under Section 22.041, Penal Code, committed on September 29, 2020, in the 8th Judicial District Court of Hopkins County, Texas, under Cause No. 2028145. As a result of the plea, the proceedings against Respondent were deferred without entering an adjudication of Guilt and Respondent was placed on probation for a period of five (5) years and ordered to pay a fine and court costs.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(3), Texas Occupations Code.
