ORDER OF THE BOARD

On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of JODELL RUTH FRIEMAN, Registered Nurse License Number 538078, and Vocational Nurse License Number 93148, hereinafter referred to as Respondent.

This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived notice and hearing and agreed to the entry of this Order.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Respondent's license to practice as a vocational nurse in the State of Texas is in inactive status. Respondent's license to practice as a professional nurse in the State of Texas is in retired inactive status.
2. Respondent waived notice and hearing, and agreed to the entry of this Order.
3. Respondent received a Certificate in Vocational Nursing from Harris School of Vocational Nursing, Fort Worth, Texas, on August 23, 1981. Respondent received a Baccalaureate Degree in Nursing from Texas Christian-Harris College, Fort Worth, Texas, on August 1, 1984. Respondent was licensed to practice vocational nursing in the State of Texas on December 11, 1981. Respondent was licensed to practice professional nursing in the State of Texas on March 23, 1987.

5. On or about October 11, 2001, Respondent was issued the sanction of Warning with Stipulations through an Order of the Board. A copy of the October 11, 2001, Order is attached and incorporated herein by reference as part of this Order.
6. On or about June 21, 2007, Respondent was required to successfully complete the Texas Peer Assistance Program for Nurses (TPAPN) through an Order of the Board. A copy of the June 21, 2007, Order is attached and incorporated herein by reference as part of this Order.
7. On or about February 8, 2010, the Board accepted the Voluntary Surrender of Respondent's license(s) to practice nursing in the State of Texas through an Order of the Board. A copy

of the February 8, 2010, Order is attached and incorporated herein by reference as part of this Order.

8. On or about August 6, 2013, Respondent's license(s) to practice nursing in the State of Texas was/were Reinstated and Respondent was prohibited from providing patient care through an Order of the Board. A copy of the August 6, 2013, Order is attached and incorporated herein by reference as part of this Order.
9. On or about September 14, 2021, Respondent's license(s) to practice nursing in the State of Texas was/were Reinstated through an Order of the Board. A copy of the September 14, 2021, Order is attached and incorporated herein by reference as part of this Order.
10. On or about December 8, 2022, Respondent's license(s) to practice nursing in the State of Texas was/were Suspended and Respondent was required to successfully complete the Texas Peer Assistance Program for Nurses (TPAPN) through an Order of the Board. A copy of the December 8, 2022, Order is attached and incorporated herein by reference as part of this Order.
11. On or about December 12, 2023, the Board provided notice to Respondent that an investigation was being initiated into alleged violations of the Nursing Practice Act and/or the Board's Rules and Regulations Relating to Nurse Education, Licensure, and Practice, as follows:
 - o On or about November 2023, you became noncompliant with the Agreed Order for Texas Peer Assistance Program (TPAPN) issued to you by the Texas Board of Nursing on December 8, 2022. Noncompliance is the result of your failure to comply with all requirements of the Texas Peer Assistance Program for Nurses (TPAPN) participation agreement, in that you voluntarily withdrew from the program and informing staff you were "leaving the nursing profession".
12. On January 8, 2024, the Board received a notarized statement from Respondent voluntarily surrendering the right to practice nursing in Texas in lieu of completing the Order. A copy of Respondent's statement, dated December 28, 2023, is attached and incorporated herein by reference as part of this Order.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451 - 301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.

3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.12(11)(B).
4. The evidence received is sufficient cause pursuant to Section 301.452(b)(1)&(10), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 538078, and Vocational Nurse License Number 93148, heretofore issued to JODELL RUTH FRIEMAN, including revocation of Respondent's license(s) to practice nursing in the State of Texas.
5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
6. Under Section 301.453(d), Texas Occupations Code, as amended, the Board may impose conditions for reinstatement of licensure.
7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 TEX. ADMIN. CODE §213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

TERMS OF ORDER

NOW, THEREFORE, IT IS ORDERED that the VOLUNTARY SURRENDER of Registered Nurse License Number 538078, and Vocational Nurse License Number 93148 is accepted by the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice professional/registered nursing, use the title "registered nurse" or the abbreviation "RN" or wear any insignia identifying herself/himself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT practice vocational nursing, use the title "vocational nurse" or the abbreviation "LVN" or wear any insignia identifying herself/himself as a vocational nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a vocational nurse during the period in which the license is surrendered.

3. RESPONDENT SHALL NOT petition for reinstatement of licensure until:
 - A. At least one (1) year has elapsed from the date of this Order; and
 - B. RESPONDENT has objective, verifiable proof of twelve (12) consecutive months of sobriety immediately preceding the petition.
4. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

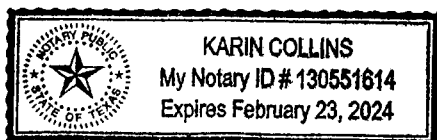

6. On or about October 11, 2001, Respondent was issued the sanction of Warning with Stipulations through an Order of the Board. A copy of the October 11, 2001, Order is attached and incorporated herein by reference as part of this Agreed Order.
7. On or about June 21, 2007, Respondent was required to successfully complete the Texas Peer Assistance Program for Nurses (TPAPN) through an Order of the Board. A copy of the June 21, 2007, Order is attached and incorporated herein by reference as part of this Agreed Order.

8. On or about February 8, 2010, the Board accepted the Voluntary Surrender of Respondent's license(s) to practice nursing in the State of Texas through an Order of the Board. A copy of the February 8, 2010, Order is attached and incorporated herein by reference as part of this Agreed Order.
9. On or about August 6, 2013, Respondent's license(s) to practice nursing in the State of Texas were Reinstated and Respondent was prohibited from providing patient care through an Order of the Board. A copy of the August 6, 2013, Order is attached and incorporated herein by reference as part of this Agreed Order.
10. On or about September 14, 2021, Respondent's license(s) to practice nursing in the State of Texas were Reinstated through an Order of the Board. A copy of the September 14, 2021, Order is attached and incorporated herein by reference as part of this Agreed Order.
11. At the time of the incident, Respondent was not employed in nursing.
12. On or about February 2, 2022, Respondent became non-compliant with the Agreed Order issued to her by the Texas Board of Nursing on September 14, 2021. Non-compliance is the result of her failure to successfully complete the Texas Peer Assistance Program for Nurses (TPAPN). Section III, Part D of the Agreed Order, dated September 14, 2021, states:

D. PETITIONER SHALL comply with all requirements of the TPAPN participation agreement during its term and SHALL keep all applicable license(s) to practice nursing in the State of Texas in current status.

On or about December 3, 2021, Respondent underwent an evaluation and was deemed unsafe to practice within the full scope of nursing practice. The evaluator suggested Respondent should pursue a Minimum Data Set nursing position or other positions that do not require direct patient care. On or about February 2, 2022, Respondent was dismissed from the TPAPN and referred to the Board.
13. On or about August 10, 2022 to August 11, 2022, Respondent underwent a self-referred evaluation with psychologist Dr. Amanda Stanley. Dr. Stanley determined that Respondent's mental health condition is in remission and that it did not prevent her from practicing nursing with patient care privileges, as long as Respondent continues to comply with treatment recommendations. Dr. Stanley stated that TPAPN may be appropriate.
14. In response to Finding of Fact Number Twelve (12), Respondent states that the doctor who completed her evaluation for the TPAPN program was biased and wrong when she determined Respondent should not administer medications. Respondent previously stated that she and the director of TPAPN decided together that the program was not appropriate for her and that she did not want to participate in the program. Respondent now states that she would now like to return to TPAPN with patient care privileges.

15. Respondent's compliance with the terms of a Board approved peer assistance program should be sufficient to protect patients and the public.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violation(s) of 22 TEX. ADMIN. CODE §217.12(9)&(11)(B).
4. The evidence received is sufficient cause pursuant to Section 301.452(b)(1)&(10), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 538078, and Vocational Nurse License Number 93148, heretofore issued to JODELL RUTH COOK.
5. Pursuant to Section 301.463(d), Texas Occupations Code, this Agreed Order is a settlement agreement under Rule 408, Texas Rules of Evidence, in civil or criminal litigation.
6. The Board may, in its discretion, order a nurse to participate in a peer assistance program approved by the Board if the nurse would otherwise have been eligible for referral to peer assistance pursuant to Section 301.410, Texas Occupations Code.

TERMS OF ORDER

I. SANCTION AND APPLICABILITY

IT IS THEREFORE AGREED and ORDERED that Registered Nurse License Number 538078, and Vocational Nurse License Number 93148, previously issued to JODELL RUTH COOK, to practice nursing in the State of Texas is/are hereby **SUSPENDED** and said suspension is **ENFORCED** until RESPONDENT:

- A. Applies to, is accepted into, and completes enrollment in the Texas Peer Assistance Program for Nurses (TPAPN);
- B. Is cleared to safely practice as a nurse based on a fitness evaluation, as may be required by TPAPN; and

- C. Waives confidentiality and provides a copy of the fully executed TPAPN participation agreement to the Board.

IT IS FURTHER AGREED, upon verification of successful completion of the above requirements, the Suspension will be **STAYED**, and RESPONDENT will be placed on **PROBATION** for such time as is required for RESPONDENT to successfully complete the TPAPN **AND** until RESPONDENT fulfills the additional requirements of this Order.

- D. RESPONDENT SHALL submit an application for licensure renewal/reactivation, as applicable, and pay all re-registration fees, if any, and RESPONDENT'S licensure status in the State of Texas will be activated and updated to current status and to reflect the applicable conditions outlined herein.
- E. RESPONDENT SHALL comply with all requirements of the TPAPN participation agreement during its term and SHALL keep all applicable licenses to practice nursing in the State of Texas in current status.
- F. RESPONDENT SHALL CAUSE the TPAPN to notify the Texas Board of Nursing of any violation of the TPAPN participation agreement.
- G. This Order SHALL apply to any and all future licenses issued to RESPONDENT to practice nursing in the State of Texas.
- H. This Order SHALL be applicable to RESPONDENT'S nurse licensure compact privileges, if any, to practice nursing in the State of Texas.
- I. Until successfully completed, RESPONDENT may not practice nursing in the State of Texas except in accordance with the terms of this Order.
- J. As a result of this Order, RESPONDENT'S license(s) will be designated "single state" as applicable and RESPONDENT may not work outside the State of Texas in another nurse licensure compact party state using a Texas compact license.

II. COMPLIANCE WITH LAW

While under the terms of this Order, RESPONDENT agrees to comply in all respects with the Nursing Practice Act, Texas Occupations Code, §§301.001 *et seq.*, the

Rules and Regulations Relating to Nursing Education, Licensure and Practice, 22 TEX. ADMIN. CODE §§211.1 *et seq.*, and this Agreed Order.

III. SUPERSEDING ORDER

IT IS FURTHER AGREED and ORDERED that the sanction and conditions of this Agreed Order SHALL supersede all previous stipulations required by any Order entered by the Texas Board of Nursing.

IV. REMEDIAL EDUCATION COURSE(S)

In addition to any continuing education requirements the Board may require for licensure renewal, RESPONDENT SHALL successfully complete the following remedial education course(s) **within one (1) year of the suspension being stayed, unless otherwise specifically indicated:**

A Board-approved course in Texas nursing jurisprudence and ethics that shall be a minimum of six (6) hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding: Sexual Misconduct; Fraud, Theft, and Deception; Nurses with Substance Abuse, Misuse, Substance Dependency, or other Substance Use Disorder; and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. Home study and video programs will not be approved.

In order to receive credit for completion of this/these course(s), RESPONDENT SHALL CAUSE the instructor to submit a Verification of Course Completion form or SHALL submit the continuing education certificate, as applicable, to the attention of Monitoring at the Board's office. RESPONDENT SHALL first obtain Board approval of any course prior to enrollment if the course is not being offered by a pre-approved provider. *Information about Board-approved courses and Verification of Course Completion forms are available from the Board at www.bon.texas.gov/compliance.*

V. CONSEQUENCES OF CONTINUED NONCOMPLIANCE

Continued noncompliance with the unfulfilled requirements of this or any Order previously issued by the Texas Board of Nursing, as applicable, may result in further

investigation and subsequent disciplinary action, including denial of licensure renewal or revocation of RESPONDENT'S license(s) and/or privileges to practice nursing in the State of Texas.

VI. EFFECT OF NONCOMPLIANCE

SHOULD RESPONDENT fail to comply with this Order or the terms of the participation agreement with the TPAPN, such noncompliance will result in further disciplinary action including TEMPORARY SUSPENSION pursuant to Section 301.4551, Texas Occupations Code, or REVOCATION of RESPONDENT'S license(s) and nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

VII. RESTORATION OF UNENCUMBERED LICENSE(S)

TERMS OF ORDER

I. REINSTATEMENT OF PATIENT CARE PRIVILEGES AND APPLICABILITY

IT IS THEREFORE AGREED and ORDERED, subject to ratification by the Texas Board of Nursing, that the petition of JODELL RUTH COOK for reinstatement of patient care privileges in the State of Texas be **GRANTED** and the sanction of Limited License

with Stipulations previously issued to PETITIONER is hereby **LIFTED** and patient care privileges restored, subject to the remaining requirements of this Order, and:

- E. PETITIONER SHALL CAUSE the TPAPN to notify the Texas Board of Nursing of any violation of the TPAPN participation agreement.

IV. **REMEDIAL EDUCATION COURSE(S)**

In addition to any continuing education requirements the Board may require for licensure renewal, PETITIONER SHALL successfully complete the following remedial education course(s) within one (1) year of the effective date of this Order, unless otherwise specifically indicated:

- A. A Board-approved course in Texas nursing jurisprudence and ethics that shall be a minimum of six (6) hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding: Sexual Misconduct; Fraud, Theft, and Deception; Nurses with Substance Abuse, Misuse, Substance Dependency, or other Substance Use Disorder; and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. Home study and video programs will not be approved.

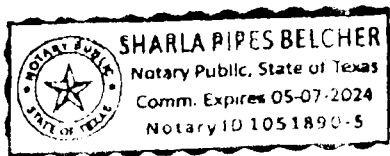

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Pursuant to Section 301.467, Texas Occupations Code, the Board may refuse to issue or renew a license, and may set a reasonable period that must lapse before reapplication. Pursuant to 22 TEX. ADMIN. CODE §213.26, the Board may impose reasonable conditions that a Petitioner must satisfy before reissuance of an unrestricted license.

IT IS FURTHER AGREED and ORDERED that while Petitioner's license(s) is/are encumbered by this Order, Petitioner may not work outside the State of Texas pursuant to a nurse licensure compact privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Petitioner wishes to work.

(1) While under the terms of this Order, RESPONDENT SHALL NOT provide direct patient care. For the purposes of this Order, direct patient care involves a personal relationship between the Nurse and the client, and includes, but is not limited to: teaching, counseling, assessing the client's needs and strengths, and providing skilled nursing care.

(2) SHOULD RESPONDENT desire to return to a clinical practice setting, which would require her to provide direct patient care, RESPONDENT SHALL petition the Board for such approval, at which time, the RESPONDENT MUST satisfy all then existing requirements for re-issuance of the privilege to provide direct patient care. Further, the Board may impose reasonable conditions that must be satisfied by the RESPONDENT before re-issuance of an unencumbered license.

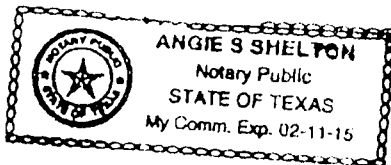



ORDER OF THE BOARD

On this day, the Texas Board of Nursing, hereinafter referred to as the Board, accepted the voluntary surrender of Registered Nurse License Number 538078 and Vocational Nurse License Number 93148, issued to JODELL RUTH COOK, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Respondent is currently licensed to practice professional nursing in the State of Texas. Respondent's license to practice vocational nursing in the State of Texas is currently in delinquent status.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
3. Respondent received a Diploma in Vocational Nursing from Harris School of Vocational Nursing, Fort Worth, Texas on August 23, 1981. Respondent was licensed to practice vocational nursing in the State of Texas on December 11, 1981. Respondent received a Baccalaureate Degree in Nursing from Texas Christian-Harris College, Fort Worth, Texas on August 1, 1984. Respondent was licensed to practice professional nursing in the State of Texas on March 23, 1987.
4. Respondent's complete nursing employment history is unknown.

5. On or about October 11, 2001, Respondent was issued the sanction of a Warning with Stipulations through an Agreed Order by the Board of Nurse Examiners for the State of Texas. A copy of the Finding of Fact, Conclusions of Law and Agreed Order dated October 11, 2001 is attached and incorporated herein by reference as part of this Order.
6. On or about June 21, 2007, Respondent was issued an Agreed Order by the Texas Board of Nursing, requiring her to participate in the Texas Peer Assistance Program for Nurses (TPAPN).. A copy of the Findings of Fact, Conclusions of Law and Order dated June 21, 2007 is attached and incorporated herein by reference as part of this Order.
7. On or about November 9, 2009, the Texas Board of Nursing notified Respondent of the following allegation:

- On or about October 23, 2009, Respondent failed to comply with the Agreed Order issued to her by the Board of Nurse Examiners for the State of Texas on June 5, 2007. Respondent's non-compliance is her failure to comply with Stipulation Number three (3), which reads:

(3) RESPONDENT SHALL comply with all requirements of the TPAPN contract during its term.

Specifically, Respondent was unable to maintain one (1) year of successful monitored nursing practice. Respondent had been fired from numerous positions for not following facility policy, unprofessional behavior, and medication errors.

8. On January 29, 2010, Respondent submitted a notarized statement to the Board voluntarily surrendering the right to practice professional and vocational nursing in Texas. A copy of Respondent's notarized statement, dated January 26, 2010, is attached and incorporated herein by reference as part of this Order.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(1) & (10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(9)&(11)(B).

4. Under Section 301.453(e), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
5. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
6. Any subsequent reinstatement of this license will be controlled by Section 301.452 (b), Texas Occupations Code, and 22 TAC §§213.26-29, and any amendments thereof in effect at the time of the reinstatement.

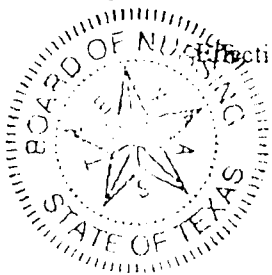

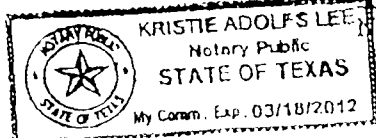

IT IS FURTHER AGREED and ORDERED that while Respondent's licenses are encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED, SHOULD RESPONDENT fail to comply with this Order or the terms of the participation agreement with the TPAPN, such noncompliance will result in further disciplinary action including revocation of Respondent's licenses and multistate licensure privileges, if any, to practice vocational and professional nursing in the State of Texas.



On or about August 25, 1999, while employed with Harris Methodist Fort Worth, Fort Worth, Texas, Respondent inadvertently administered Clonidine (an anti-hypertensive) two tenths milligram (.2mg) to Medical Record # 903488644T002, a patient who was admitted for the treatment of Crohn's disease. The physician ordered Klonopin (a benzodiazepine) two (2) milligrams (mg) to be given to the patient. Respondent's action of administering the Clonidine unnecessarily exposed the patient to the risk of adverse effects from the medication, including hypotension, bradycardia, and dizziness.
8. During April 1999, while employed with Harris Methodist Fort Worth, Fort Worth, Texas, Respondent failed to administer morphine sulfate for the Patient Controlled Analgesia (PCA) pump for Medical Record # 462148524015, as ordered by the physician. Respondent signed out Demerol for the Patient Controlled Analgesia (PCA) pump and administered the medication over a three (3) hour period to the aforementioned patient. Respondent's action of administering the Demerol unnecessarily exposed the patient to the risk of harm from adverse effects of the medication, including sedation and hypotension.
9. On or about September 29, 1999, while employed with Harris Methodist Fort Worth, Fort Worth, Texas, Respondent failed to administer albumin intravenously (IV) as ordered by the physician to Medical Record # 1022822, a patient who was admitted for a left septic knee and left thigh wound infection. The patient had a decreased serum albumin level. Respondent's failure to administer albumin unnecessarily exposed the patient to a delay in healing.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(13), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.11(3).

4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against License Number 538078, heretofore issued to JODELL RUTH COOK, including revocation of Respondent's professional license to practice nursing in the State of Texas.

ORDER

IT IS THEREFORE AGREED and ORDERED, subject to ratification by the Board of Nurse Examiners, that RESPONDENT SHALL receive the sanction of a Warning with Stipulations, and RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Revised Civil Statutes of Texas as amended, Texas Occupations Code, §§301.001 *et seq.*, the Rules and Regulations Relating to Professional Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.01 *et seq.* and this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privilege, if any, to practice professional nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED that:

(1) RESPONDENT SHALL deliver the wallet-size license issued to JODELL RUTH COOK, to the office of the Board of Nurse Examiners within ten (10) days of the date of this Order for appropriate notation.

(2) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in nursing jurisprudence. RESPONDENT SHALL obtain Board approval of the course prior to enrollment. Home study courses and video programs will not be approved. In order for the course to be approved, the target audience must include registered nurses. It must be a minimum of six (6) contact hours in length. The course's content shall include the Nursing Practice Act, standards of practice, and documentation of care. Courses focusing on malpractice issues will not be accepted. RESPONDENT SHALL CAUSE the sponsoring institution to submit a Verification of Course Completion form, provided by the Board, to the Office of the Board to verify RESPONDENT's successful completion of the course. This course is to be taken in addition to any continuing education requirements the Board may have for relicensure.

(3) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in medication administration. RESPONDENT SHALL obtain Board approval of the course prior to enrollment. Home study courses and video programs will not be approved. The target audience must include registered nurses. The didactic portion of this course must be a minimum of six (6) hours in length. The course must contain a minimum twenty-four (24) hour clinical component which is to be supervised by another registered nurse. To be approved, the course's content must include a review of proper administration procedures for all standard routes, computation of drug dosages, the five (5) rights of medication administration, factors influencing medication route, and adverse effects resulting from improper administration. The description must indicate goals and objectives for the course, resources to be utilized, and the methods to be used to determine successful completion of the course. RESPONDENT SHALL successfully complete both the didactic and clinical portions of the course to satisfy this stipulation. RESPONDENT

SHALL CAUSE the instructor to submit a Verification of Course Completion form, provided by the Board, to the office of the Board to verify RESPONDENT's successful completion of the course. This course is to be taken in addition to any continuing education requirements the Board has for relicensure.

IT IS FURTHER AGREED, SHOULD RESPONDENT CHOOSE TO PRACTICE AS A REGISTERED NURSE IN THE STATE OF TEXAS, RESPONDENT WILL PROVIDE DIRECT PATIENT CARE AND PRACTICE IN A HOSPITAL, NURSING HOME, OR OTHER CLINICAL SETTING, UNDER THE FOLLOWING STIPULATIONS FOR ONE (1) YEAR OF EMPLOYMENT:

(4) RESPONDENT SHALL notify each present employer in professional nursing of this Order of the Board and the stipulations on RESPONDENT's license. RESPONDENT SHALL present a copy of this Order to each present employer within five (5) days of receipt of this Order. RESPONDENT SHALL notify all future employers in professional nursing of this Order of the Board and the stipulations on RESPONDENT's license. RESPONDENT SHALL present a copy of this Order to each future employer prior to accepting an offer of employment.

(5) RESPONDENT SHALL CAUSE each present employer in professional nursing to submit the Notification of Employment form, which is provided by the Board, to the Board's office within ten (10) days of receipt of this Order. RESPONDENT SHALL CAUSE each future employer to submit the Notification of Employment form to the Board's office within five (5) days of employment as a professional nurse.

(6) RESPONDENT SHALL CAUSE each employer to submit, on forms provided by the Board, periodic reports as to RESPONDENT's capability to practice professional nursing.

These reports shall be completed by the Registered Nurse who supervises the RESPONDENT.
These reports shall be submitted to the office of the Board at the end of each three (3) months for
one (1) year of employment as a professional nurse.

IT IS FURTHER AGREED, that upon full compliance with the terms of this Order,
RESPONDENT SHALL be issued an unencumbered license and multistate licensure privileges, if
any, to practice professional nursing in the State of Texas.

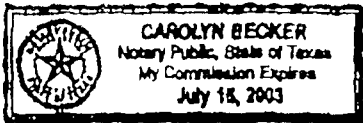
